3. Clarification to bidders' queries:

1	Shipment handover delay after confirmation.	Instructions shall be provided to the Freight Forwarder only after receipt of Cargo readiness intimation from the shipper, we will instruct shipper to handover the cargo at the earliest possible.
2	Providing packing list in advance if possible	Packing list shall be shared with Freight Forwarder immediately upon receipt from the shipper.
3	Exchange rate consideration as per freight forwarder bank for generating Invoice and payments.	As mentioned in the tender
4	Whether Cargo Stackable or Non Stackable	Maximum cargo shall be non-stackable.
5	Are there any Over Dimensional Cargo	Refer to Section VII: Technical Specification / Scope of Work – Point 2.6 (Page no. 34) rates quoted in the tender shall be applicable for normal cargo. Rates for Over Dimensional Cargo (ODC) shall be sought on case to case basis.
6	Cargo Packing will be Corrugated Box or will it be of Wooden & pallets	Based on cargo, packing can be corrugated box or wooden box or Pallet. Details of the packing shall be specified in the packing list.

8	The rate will be applicable only for general cargo and not for DGR/ODC cargo.	Refer to Section-VII: Technical Specifications/ Scope of Work – Point no. 2.6 (Page no. 34 of tender document): specifies that rates quoted in the tender shall be applicable for normal cargo. In case of Dangerous Goods (DGR) and Over Dimensional Cargo (ODC) rates shall be settled on case to case basis.	
9	Can we sign all documents via Digital signature, instead of manual signature	Tender documents signed by digital signature shall be acceptable subject to representative signing the tender document holds valid authorisation to submit tender on behalf of the bidder.	
10	In case if the shipper does not agree to pay the FCA charges then the same will be paid by Bank Note.	BNPM shall clearly specify the Incoterms while advising shipment pick up. Further, it may be noted that majority of the shipment shall be on F.C.A / F.O.B basis from the ports for which rates has been sought in the tender. Charges applicable to shipper as per incoterms shall be borne by shipper and any arrangement between shipper and freight forwarder regarding charges prior to F.C.A / F.O.B - contracted ports shall be between Shipper and Freight Forwarder.	
11	In case of ex-works shipments do we have to take the permission of Bank Note.	In case cargo / shipment is on Ex-works basis, then prior approval from BNPM is required for the charges that will be incurred for Ex-work to F.C.A/F.O.B – contracted ports.
