1. Tenders are to be uploaded on e-tendering portal www.tenderwizard.com/BNP only in Two part bid system.

2. i) **Part-I – Prequalification Bid & Techno-commercial Bid:** Scanned copy of Technical offer (catalogue/brochure etc.), Certificate of Incorporation/Partnership Deed (as applicable), GST, PAN, Bank details etc., along with all sections & annexures of this tender.

ii) **Part II – Price Bid:**

Price shall be furnished through e-portal only. Price offer submitted in any other format will be liable for rejection.

3. **Payment terms:**

- 100% amount of the invoiced value shall be released within 30 days on receipt and acceptance of complete supply by the consignee at destination (i.e. BNPM, Mysuru) and on production of all required documents by the supplier.
- Payment will be made only if the supplied consignment meets the specifications & quality criteria mentioned in the Technical Specifications.

4. **Delivery Schedule:** Successful bidder shall complete supply of goods within **14 weeks** from date of placement of purchaser order (Ref scope of supply).

5. **Warranty:** The supplier warrants that the goods supplied under the contract is new, unused and shall have no defect arising from design, materials (except when the design adopted and / or the material used are as per BNPM's specifications) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India. This warranty shall remain valid for **Twelve (12) months** after the goods or any portion thereof as per the tender, have been delivered to the final destination and accepted by BNPM. In case of any claim arising out of this warranty, BNPM shall promptly notify the same in writing to the supplier and within a mutually agreed time supplier shall repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination.

6. **Performance Security:** - Within 21 days after the issue of notification of award by BNPM, the successful bidder shall furnish performance security to BNPM for an amount equal to (5%) five per cent of the total value of the contract valid up to 12 Months warranty period plus two months claim period thereafter. The Performance security shall be denominated in Indian Rupees or in the currency of the contract and shall be in one of the following forms:

- Account Payee Demand Draft drawn on any commercial bank in India, in favour of Bank Note Paper Mill India Private Limited.
- Fixed Deposit (FDR) from a scheduled commercial bank in India;
- Un-conditional Bank Guarantee issued /confirmed from any of the commercial bank in India as per Section XV of tender, valid up to sixty days after the date of completion of all contractual obligations by the supplier, including the warranty obligations.

9. All supplies are subject to inspection and approval before acceptance. Refer Section III – Technical Specifications & scope.
10. BNPMIPL reserves the right to increase/decrease the quantity specified in this enquiry at the time of placement of order at the quoted price.
11. The prices quoted should be firm till the supplies are completed. Rates quoted should be door deliver basis as per price schedule/ price bid at destination including all charges otherwise the quotation will be rejected. Price quoted should be net and valid up to the completion of all contractual obligations.
12. **Evaluation Criteria:**
- (i) The technical bids shall be opened in the first instance and these bids shall be scrutinized and evaluated by the competent committee/ authority with reference to the parameters prescribed in the tender document. Subsequently, in the second stage the financial bids of only techno-commercially qualified bidders as decided in first stage shall be opened for further scrutiny and evaluation. If any bidder submit/ disclose their price in their techno-commercial bid, their bid will be disqualified.
 - (ii) **Method of Evaluation:** Evaluation shall be carried out on **overall lowest effective price** (i.e., without GST) quoted by the bidders, unless any other method of evaluation is specifically provided in the enquiry and contract shall be awarded to **overall lowest (L-1) bidder**. The quoted price should be inclusive of P&F, Freight, Transit Insurance and any other charges required for delivery of item to BNPM, Mysuru on F.O.R basis.
 - (iii) **Price Tie:** L1 shall be awarded based on date of incorporation of company, such as proprietorship & partnership firms, date of GST registration & execution of partnership agreement respectively shall be taken as date of incorporation.
 - (iv) All responsive tenderers shall be evaluated as per the terms & conditions of the tender. The basis for arriving at the lowest responsive bidder shall be as per the price quoted for landed cost at Mysuru including GST, packing & forwarding charges, freight, insurance and any other charges etc. i.e., as per price schedule/ price bid and input credit shall be deducted to arrive at the effective price. Effective price shall be considered for arriving the lowest responsive bidder.
 - (v) Bidder has to mention appropriate HSN code and quote GST rate provided in Price Schedule. In case of any mismatch in HSN code with respect to offered product, same shall be decided in consultation with winning bidder

(vi) All tenderers should be registered under GST. They should be eligible to pass on input credit. Bid will be evaluated all-inclusive though input credit will be deducted to arrive at the effective cost.

*If the bidders participated in a tender is unregistered, the GST shall be payable by the purchaser under reverse charge and shall be added to the quoted rate to arrive at the Gross price and input credit, if any shall be deducted from the total landed cost to arrive at the net comparable price.

13. Payment of GST is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the quotations. If no indication regarding GST is recorded in the quotation, the GST will be considered as included.

14. **Delay in supplier's performance:** Time for and the date specified in the contract or as extended for the delivery of the stores shall be deemed to be the essence of the contract and the supplier shall deliver the goods and perform the services under the contract within the time schedule specified by BNPM in the contract.

Any delay attributable to the supplier in maintaining its contractual obligations towards delivery of goods and performance of services may render the supplier liable to any or all the following sanctions besides any administrative action such as (a) Termination of contract for default; (b) Forfeiture of performance security.

15. **Extension of Time:** If the contract is delayed in the progress of work by changes ordered in the work, or any clause which BNPM shall decide to justify the delay, then the time of completion shall be extended by a reasonable time.

If at any time during the currency of contract, the supplier encounters conditions hindering timely delivery of the goods and performance of services, the supplier shall promptly inform BNPM in writing about the same and its likely duration and make a request to BNPM for extension of the delivery schedule accordingly. On receiving the supplier's communication, BNPM shall examine the situation as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liquidated damages for completion of supplier's contractual obligations by issuing an amendment to the contract.

16. **Force Majeure:** In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by BNPM in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s)

mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.

17. **Fore-Closure Clause:** If at any time during the continuation of this contract, the use of material ordered in this contract is completely banned or due to drastic change in Government policy its use as, raw material is discontinued or is declared hazardous to public health or cause rising to civil commotion, epidemics, wide-spread strikes and 21 days' notice of such eventualities is given by purchaser to the seller, the seller without any right to enforce the contract, will agree to the fore-close the performance of balance portion of this contract and in that event no claim for damages or loss will be lodged against the purchaser.
18. **Obligations by bidders:**
- i) All bidders are obliged under the CIPP (Code of integrity of public procurement) to suo moto proactively declare any conflict of interest (as per conflict of interest clause) in any procurement process or execution of contract. Failure to do so would amount to violation of this Code of Integrity; and
 - ii) Any bidder must declare, whether asked or not in a bid document, any previous transgressions of such a Code of Integrity with any entity in any country during the last 1 (One) year of being debarred by any other Procuring Entity. Failure to do so would amount to violation of this code of integrity.
19. **Conflict of Interest:**
- Bidders having a conflict of interest shall not be eligible to participate in the tender process unless the conflict stemming from such relationship has been resolved in a manner acceptable to the Procuring Entity throughout the Tender process and execution of the Contract. Bidder have to abide by the code of integrity of public procurement. The bidder shall be considered to have a conflict of interest in this tender process and execution of the resultant contract in the following situations:
- a) If its personnel have a close personal, financial, or business relationship with any personnel of the procuring entity who are directly or indirectly related to the procurement or execution process of the contract, which can affect the decision of the procuring entity directly or indirectly;
 - b) The bidder (or his allied firm as defined by DOE, MOF,GOI) provided services for the need assessment/procurement planning of the Tender process in which it is participating;
 - c) A Principal can authorize only one agent, and an agent should not represent or quote on behalf of more than one Principal. However, this shall not debar more than one Authorised distributor (with/ or without the OEM) from quoting equipment manufactured by an Original Equipment Manufacturer (OEM) in procurements under Proprietary Article Certificate or
 - d) A bidder participates in more than one bid in this tender process. Participation in any capacity by a Bidder (including the participation of a Bidder as a partner/ JV member or sub-contractor in another bid or vice-versa) in more than one bid shall result in the disqualification of all bids in which he is a party. However, this does not limit the participation of an entity as a sub-contractor in more than one bid if he is not bidding independently in his own name or as a member of a JV.

22. The BNPMIPL reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reason thereof and does not bind itself to accept lowest quotations.
23. **Settlement of Disputes through Arbitration:** All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after their completion except accepted matters shall be settled through arbitration process as per the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysuru, Karnataka.
24. **Legal Jurisdiction:** The Courts of Mysuru (Karnataka State) shall alone have jurisdiction to decide on any legal matter of dispute whatsoever arising out or in respect of the contract.
25. **Rights of Rejection:** BNPMIPL reserves the right to reject any or all the applied bids without assigning any reason whatsoever. The enquiry can be rejected on national security grounds.
26. **Preference for Micro and Small Enterprises (*MSEs):**
Public procurement policy for Micro and Small Enterprises (MSEs) order, 2012 as notified by Govt. of India (GOI) along with its amendments as available in www.msme.gov.in shall be applicable to this tender. *MSEs should have valid Udyam Registration Certificate to be eligible for consideration under preference for Micro and Small Enterprises (*MSEs). Benefits of Retail and Wholesale traders are restricted upto Priority Sector Lending (PSL) only. Scope of Supply, inspection,report submission:

1. Bidder need to submit the Dimensional report and material test i.e MOC certificate (either from Material OEM or NABL approved lab) to BNPM along with material supply. If required BNPM will also counter check the same from the supplied material.
2. Successful bidder need to offer inspection call for the 1st number of each item of Purchase order for checking (within 7 km radius from BNPM). Bidders who are not in the 7km radius from BNPM need to supply one number in each item of purchase order for inspection at BNPM.
3. Initially one set will be checked for dimension and clearance will be given for manufacturing 2nd set of gears. On receipt of both sets, both will be fixed on the machine and checked while running. On successful running the material will be accepted. Successful bidder may visit at the time of fixing & running to understand the changes/modifications required, if any and to incorporate the same as required.
4. If the item is not made as per Purchase order specification, it is the bidder's responsibility to repeat the same and to confirm Purchase order specification. This entire sample process to be completed within 45 days from the receipt of purchase order. If the successful bidder have to manufacture multiple samples due to the failure or rejection of initial / subsequent samples, they will not be paid for the same failed and/or rejected items.
5. BNPM will give the clearance of inspection by mail to the successful bidder within 7 days from the date of inspection call/ receipt of sample mentioned at BNPM (whichever is later).
6. After getting the inspection clearance from BNPM, the bidder can start manufacture the remaining items with any corrections required by BNPM. Successful bidder should supply remaining materials within 45 days after BNPM clearance.
7. On inspection of remaining material, if any deviation is found from the accepted sample, then new material need to be supplied by successful bidder and then only rejected lot will be permitted to taken out from BNPM at the risk &cost of the supplier.
8. Payment will be made only after supplying the complete Purchase order quantity and acceptance of the same.

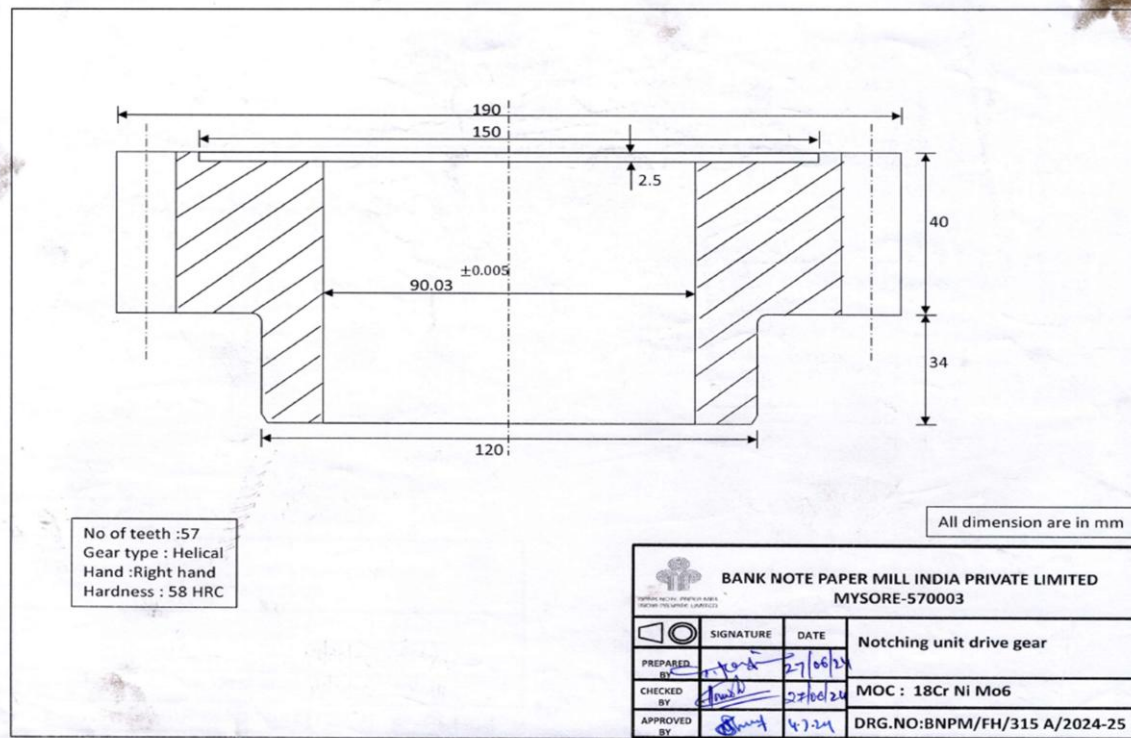

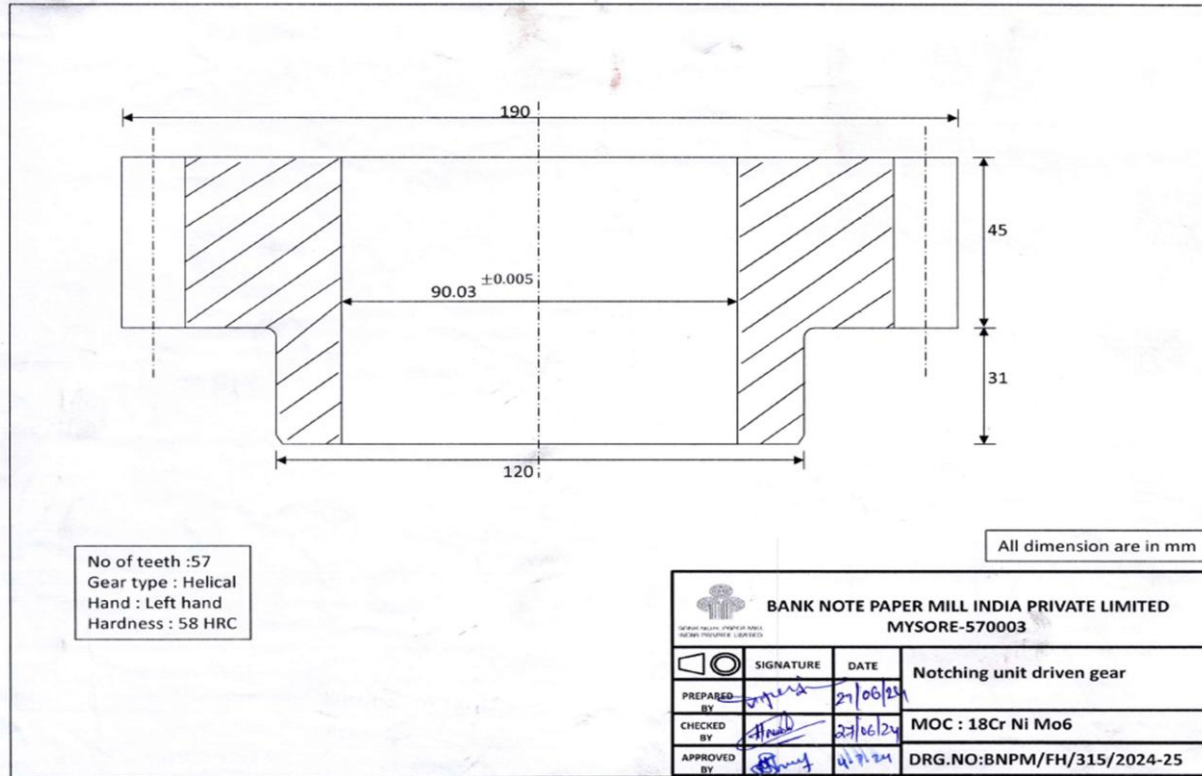
