#### **I. NOTICE INVITING TENDER**

Bank Note Paper Mill India Private Limited (BNPM) is a joint venture company between Bharatiya Reserve Bank Note Mudran Private Limited (A wholly owned subsidiary of Reserve Bank of India) and Security Printing and Minting Corporation of India Limited (100% owned by Government of India), incorporated for setting up & manufacturing of bank note papers at Mysore.

#### 5. Exemption from Payment of EMD:-

The tenderers who are currently registered and, also, will continue to remain registered during the tender validity period with DGS&D or with National Small Industries Corporation, New Delhi/MSME are exempted from payment of earnest money. - 6. - 7. Tenders should be submitted in a sealed cover, to the offices of the BNPM, super subscribed "conducting topographical survey by using topographical scanner, DGPS & total station at BNPM Premises". The tender shall be submitted as follows:

#### 8. Receipt of Tender:

All pages of tender documents, General terms and conditions and other supporting documents shall be duly stamped, signed & submitted by the tenderer, as a token of having read and accepted all the terms & conditions.

9. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected.

- 10. Tenderers should quote their prices and rates both in figures and in words. No blank spaces shall be left. All erasures and corrections made while filling up the tender shall be initiated by the tenderer.
- 11. The tender shall remain open for acceptance for a period of 60 days from the date of opening of the tender.

#### 12. EVALUATION CRITERIA:

- a. At first stage, techno-commercial bid (Envelope-1) will be opened and evaluated by the competent committee/authority with reference to the parameters prescribed in the tender document. Subsequently, in the second stage the financial bids (Envelope-2) of only technically acceptable offers as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.
- b. The method of evaluation of bidder for awarding the contract shall be on overall L-1 basis inclusive of GST
- 13. The rates quoted will be treated inclusive of all charges and no further claims whatsoever will be entertained in this respect. The quoted rates should be F.O.R (Free On Road) Mysore site basis. However GST shall be paid extra at actuals.
- 14. The acceptance of the tender document will rest with the Owner, who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tender's received without assigning any reason thereof.

## **15.Terms of Payment:**

(i) 100% of the bill value shall be paid on completion of works and submission of reports as per the satisfaction of engineer in charge and certification of engineer in charge.

Payments to suppliers shall be made by account payee cheque or through ECS only.

- **16. Time Period:** The time period for conducting Topographical survey by using topographical scanner, DGPS & total station at BNPM Premises is **1 month** from the date of Work order/Purchase Order. Time is the essence of this contract.
- 17. **Delay or Non Delivery**: Time is essence of the contract and completion of work agreed to be binding on the contractor. In the event the contractor is not able to complete the work as per the time schedules given by BNPM, OWNER will have right either to cancel the order without prejudice to any other rights or to make purchase from an alternate source at the risk and cost of the contractor.

In case of un satisfactory work, the order will be treated as incomplete and we may cancel the order and will arrange to execute the work from elsewhere at your risk and cost and the Work order / Purchase Order / LOI on you will be cancelled and action taken as per the order terms.

- 18. **Liquidated Damages:** The Employer/Owner shall levy a penalty at the rate of 0.5% for the balance works per week or part thereof of delay in delivery up to a maximum of 10% of the delayed goods.
- 19. **Tender Evaluation and award of work**: Tenders will be evaluated as per the terms and based on responsiveness taking into account all relevant factors. While the lowest offer will generally be the criteria, BNPM reserves the right to reject any offer including the lowest one if the same is not conforming to its norms. The decision of BNPM in this regard will be final.
- 20. **Settlement of Disputes:** All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after their completion except accepted matters shall be settled through arbitration process as per the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysore, Karnataka.
