I. NOTICE INVITING TENDER

Bank Note Paper Mill India Private Limited (BNPM) is a joint venture company between Bharatiya Reserve Bank Note Mudran Private Limited (A wholly owned subsidiary of Reserve Bank of India) and Security Printing and Minting Corporation of India Limited (100% owned by Government of India), incorporated for setting up & manufacturing of bank note papers at Mysore.

1. E - Bids are invited by BNPM from eligible & financially sound bidders for **Sale of Empty Bobbins (Reusable Purpose) at BNPM, Mysore – 570003.**

Online mode of bid submission (e tender):-

- b. Aspiring Bidders/Contractors who have not registered in e-tendering should register through the website E - Tendering (www.tenderwizard.com/BNP) for participating in the Online Tenders. **The registration charges will be Rs. 3,000/- plus applicable taxes (per year) which needs to be paid through electronic mode only. Tender processing fee is Rs. 3,000/- plus applicable Taxes.**

- d. The NIT along with tender documents will be accessible in the e-Tendering website (viz www.tenderwizard.com/BNP).
- e. Class III Digital Signature Certificate (DSC) is mandatory to participate in e-Tenders. Participating bidders/Contractors have to make sure that they have the valid DSC. If not, they can procure from any of the RAs approved by CCA.
- f. Bidders/Contractors should upload and attach all the Scanned copies of technical documents/certificates in e-tendering website www.tenderwizard.com/BNP pertaining to their eligibility criteria mentioned in the NIT, failing which, the bid will not be considered.

2. **Eligibility Criteria:** The prospective bidders should submit the documents as mentioned below.

- a) Proof of registration i.e., valid GST and PAN.
- b) The bidder should be manufacturer of Security Thread.
Documents to be submitted: Atleast One No of Order / contract / agreement copy (unpriced) carried out during last 5 years ending on 31.03.2026 should be submitted to substantiate the above criteria.

- c) Bidder shall be Individual/ firm/ company/ corporate / LLP / HUF / limited company intending to bid should be bonafide, experienced, technically competent, resourceful and financially sound to carry out the assigned order.

Documents to be submitted: Company's registration / Certificate of incorporation/Partnership Deed/Any other registration certificate as applicable.

- d) Empty Bobbins shall be used as reusable purpose- Declaration in letter head is to be submitted accordingly.

All the documents should be duly signed by the authorized person of the bidder. Power of attorney in appropriate Stamp Paper (As per respective state wise stamp act) /Board Resolution/proprietor declaration/Partners confirmation should be submitted for the signing authority from the competent authority of the company.

3. Online bids are to be submitted through e tender portal (www.tenderwizard.com/BNP) only.

Note: Against receipt of the following notification through email from tenderwizard portal, bidder must resubmit the bid even if the bidder has already submitted the bid through tenderwizard portal.

Notification: If you have already submitted the tender, then ensure that you resubmit the tender. Else, your bid may be liable to be auto disqualified by the system. And service provider holds no responsibility for the same. In case, you are yet to submit the tender, then please ensure that you submit it before the tender closing time.

Submission / resubmission of the bid is the responsibility of the bidders only. Bidder should check and confirm at their end regarding the submission/ resubmission of their bid till the due date & time of bid submission. BNPM / Keonics/ Tenderwizard will not be responsible for non-submission/ non resubmission of any bid.

4. Bid submission procedure:

Online bids:

Tenders are to be uploaded on e-tendering portal www.tenderwizard.com/BNP only in Two-part bid system.

i) Part-I - Prequalification Bid & Techno-commercial Bid: Registration Fee, Tender Processing Fee, EMD/Bid Security Declaration as per Annexure A is to be submitted (For MSE Bidder), Scanned copy of supporting documents related to eligibility criteria (As mentioned in NIT) along with all sections, annexures of this tender (except Sec – IV, Price Schedule, which has to be submitted as mentioned in Sl.No.ii below) duly signed & stamped by authorised person in each & every page. (To be submitted through e-portal only)

ii) Part II – Price Bid: Price Bid shall be submitted through e-portal only, the price bid is liable for rejection if submitted in any other mode. Price Bid should be submitted as per the price bid format provided in Sec –IV, Price Schedule of this tender. **Price Bid**

submitted in any other format will be liable for rejection. Price bids with conditions / Counter conditions are liable for rejection.

6. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected. In line with evaluation criteria bid may be submitted item/schedule wise.
7. **Bid Validity:** The tender shall remain open for acceptance for a period of 120 days from the date of opening of the tender.

8. EVALUATION CRITERIA:

At first stage, techno-commercial bid will be opened and evaluated by the competent committee / authority with reference to the parameters prescribed in the tender document. Subsequently in the second stage the financial bids of only techno commercially acceptable offer as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.

The method of evaluation of price bid for awarding the sale order shall be on overall effective price (i.e without GST) of H1 basis.

- a. H1 will be awarded for the annual requirement of the bidder (As declared by the bidder in Sec II of their bid) or **11,000 Nos**, whichever is lower.
- b. Out of the rest of the tendered quantity, the highest rate (H1 rate) will be counter offered to the H2 bidder for the annual requirement of the bidder (As declared by the bidder in Sec II of their bid) or **11,000 Nos**, whichever is lower. On acceptance of the counter offer with H1 rate, the order will be placed on H2 bidder for the annual requirement of the bidder (As declared by the bidder in Sec II of their bid) or **11,000 Nos**, whichever is lower and aforementioned procedure will be proceeded for the H3 bidder.
- c. After allocation of the quantity in the above-mentioned process if any quantity is left out then left out quantity may be offered to H1, at H1 rate and so on to other bidders.
- d. If there is any non-acceptance of the counter offer by the H2 and/or H3 bidder then left out quantity may be offered to H1, at H1 rate.
- e. If there is tie between the quoted rates of the bidders then preference will be given to the bidder having higher annual requirement of reusable empty bobbins as mentioned by the bidder in their techno commercial bid.
- f. However, the acceptance of the bid will rest with BNPM, who does not bind itself to accept the highest bid and reserves to himself the authority to reject any or all of the bids received without assigning any reason thereof.
- g. BNPM also reserves the right to allot the order partly or wholly to single or different Bidders. BNPM reserves the right to reject any offer including the highest one if the same is not conforming to its norms. The decision of BNPM in this regard will be final.

Note to bidders: If it is observed that the discovered H1 rate against this tender is found to be more than the existing rate of the running contracts (if any), then rates of all the running contracts (if any) are to be matched with the discovered H1 rate for the open quantity available or existing order may be short closed as per the discretion of BNPM.

9. Discrepancy in Prices:

- 9.1 If, in the price structure quoted by a bidder, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless BNPM feels that the tenderer has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.
- 9.2 If, there is an error in a total price, which has been worked out through addition and/ or subtraction of subtotals, the subtotals shall prevail and the total corrected; and
- 9.3 If, there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail.
- 9.4 If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the tenderer by registered/speed post/email. If the tenderer does not agree to the observation of BNPM, the tender is liable to be ignored.

10. Earnest Money Deposit (EMD):

Interest free EMD of Rs 1,91,000 /- (Rupees One Lakh Ninety-One Thousand only). The EMD shall be paid online at e tender portal (www.tenderwizard.com/BNP). The tender without EMD shall be liable for rejection.

EMD may be submitted online at e-procurement portal or vide submission of BG as per the prescribed format provided in the tender.

For MSE Bidders:

- a) Submission of EMD is exempted for Micro and Small enterprises (MSEs) as per the Public Procurement Policy for MSEs Order, 2018.
- b) MSEs should be registered and also will continue to remain registered during the tender validity period with District Industries Centre (DIC) or Khadi and Village Industries Commission (KVIC) or Khadi and Industries Board (KVIB) or Coir Board or National Small Industries Commission (NSIC) or Directorate of Handicrafts and Handlooms or UDYAM Registered or Any other body specified by Ministry of MSME.

Note:

- i. Micro and Small Enterprises (MSEs) having major activity as “Manufacturers” and “Service Providers” as per UDYAM certificate are eligible for claiming EMD exemption. EMD exemption can be claimed irrespective of NIC code specified in

UDYAM certificate.

- ii. An enterprise re-classified to “Medium” as per UDYAM Certificate may continue to avail EMD exemption from the enterprise type it was in before the re-classification (i.e. Small/Micro), for a period of three years from the date of such re-classification. An enterprise classified continuously as “Medium” beyond three cannot claim EMD exemption.
- iii. MSME’s having major activity as “Trading” for availing benefits of Priority Sector Lending (PSL) only as per UDYAM certificate are excluded from claiming EMD exemption. Such bidders are required to submit EMD as per tender, else their bid will be considered ineligible/ unresponsive and will be ignored.

For Start-up Bidders:

- 1. Submission of EMD is exempted for Start-up bidders as per the Office Memorandum No. F/20/2/2014-PPD (Pt.) of Ministry of Finance dated 25.07.2017.
- 2. Start-ups should be registered with Department for Promotion of Industry and Internal Trade (DPIIT) Bid Security Declaration as per Annexure-D is to be submitted.

Documents to be submitted:

- i. For MSE Bidders: Valid NSIC / KVIC / KVIB / DIC / UDYAM Registration certificate.
- ii. For Start-ups: Certificate of recognition issued by DPIIT.
- iii. Bid Security Declaration as per Annexure-D is to be submitted by bidders claiming exemption to EMD.

Note: Valid means valid upto Tender/bid validity period.

For Non-MSE/Start-up bidders: EMD is to be submitted.

11. Refund of EMD:

EMD of Unsuccessful bidders will be returned to them without any interest, after expiry of the tender validity period, but not later than thirty days after conclusion of the resultant contract. EMD of successful Bidder will be released on submission Security Deposit. EMD shall be released without any interest.

12. Security Deposit (SD):

Within Seven (7) calendar days after the issue of notification of award (i.e sale order) by BNPM, the successful bidder (Purchaser) shall furnish security deposit to BNPM for an amount equal to twenty-five (25) per cent (%) of the total value of the contract.

Security deposit may be furnished in the form of:

- i. Account payee demand draft
- ii. Unconditional Bank Guarantee issued and confirmed from any scheduled commercial bank in India with validity up to 60(sixty) days beyond the date of completion of all contractual obligations.
- iii. Fixed deposit receipt (FDR) from a scheduled commercial bank in India, lien marked to Bank Note Paper Mill India Pvt Ltd, Mysore
- iv. Online payment in an acceptable form.

v. Insurance surety bond

If the successful bidder fails to resume/complete the work within stipulated time, SD of such bidder shall be forfeited. SD shall be interest free.

13. Terms of Sale:

Successful Bidder (Purchaser) has to submit advance amount which is equivalent to the value of the empty bobbins to be lifted preferably 3 days before lifting the scrap material. The advance payment should be made vide electronic transfer/Deposit to the Bank Account of Bank Note Paper Mill India Pvt Ltd.

Successful Bidder (Purchaser) shall be allowed to lift the scrap material only if the advance amount is equivalent to the scrap to be lifted.

14. Site Visit/ Inspection:

To assess the state/ conditions of empty bobbins and to determine the price to be quoted, the Bidder may visit the project site on or before tender submission due date and time and to get acquainted with the conditions at the site.

15. General Terms & Conditions: Tenders for Sale of Empty Bobbins:

The tender is for Sale of Empty Bobbins. Details of items for sale including Description, Lot Size would be given in the "List of Sale of Items ".

- a. "As Is; Where Is" Basis of This Sale:
- b. This sale of Empty Bobbins is strictly on "As Is; Where Is" basis. Tenderer must satisfy himself on all matters with regard to quality, quantity; nature of stores etc., before tendering as no complaint or representation of any kind shall be entertained after the sale contract is concluded.
- c. The description of lot in the particulars of sale(if mentioned) has been given for the purpose of identification thereof only and the use of such description shall not constitute the sale thereof to be sale by description and no sale shall be invalid by reason of any defect or deviation or variation in any lot or on account of any lot not being exactly described and the purchaser shall not be entitled to claim any damage or compensation whatsoever on account of such fault, error in description, weight or the like.
- d. All quantities of Empty Bobbins whether by weight or measurement mentioned in the Tender notice are only approximate and should the quantity, on actual weight or measurement basis as the case may be and whenever delivered on such basis, works out less than the advertised and /or projected quantity, BNPM shall not under any circumstances be liable to make good any such deficiency
- e. BNPM reserves the right to increase or decrease the quantity of any item or items or terminate the contract at any stage by giving one week's notice. No claim whatsoever shall lie against the BNPM on account of such termination of the contract or variation in the quantity.
- f. Tenderers desirous of participating in the tender may visit the site before submitting the offer, after taking due permission from BNPM. The Tenderers submitting the offers shall be deemed to have visited the site and acquainted themselves thoroughly with materials intended for sale in all respect.

- g. Any person giving offer shall be deemed to have made himself fully conversant with the Terms and Conditions of the Tender Sale, as well as the location and condition of the materials being sold and shall be deemed to have agreed to all the stated terms and conditions herein under.

16. Non-Misuse Declaration:

The bidder is required to give an undertaking that he or his employees or legal heirs will ensure that such items purchased from BNPM, will be utilized only for reusable purpose and will not be misused for any other purpose. He will also ensure that this undertaking is honored. In case his firm changes hands, it will be his responsibility to ensure that the new owners honor and underwrite this undertaking.

17. Procedure for Sale of Empty Bobbins:

On finalization of tender, a sale order will be issued to successful bidder (Purchaser) by BNPM. The existing available quantity, is to be lifted vide payment of advance amount (Refer clause 13) within 15 calendar days (including the date of issue of sale order) from the date of issue of sale order or as per schedule provided by BNPM, Stores whichever is later.

Thereafter as per the schedule provided by BNPM, empty bobbins may be lifted. The successful bidder (Purchaser) shall make advance payment (Refer clause 13) for the material to be lifted. Bidder shall arrange vehicle, if any, Tools & tackles /materials required & labour for collection from various places in the site, loading, transportation at his own cost.

In case of delay in advance payment, BNPM may grant an extension of time for the payment with late payment charges @ one per cent (1%) per week or part thereof up to two weeks only and, thereafter, the SD will stand forfeited without notice. No interest will be paid to the purchaser for the amounts paid or deposited and subsequently found refundable to the purchaser under any of the conditions of the contract. This extension will not be a routine process.

The safety of the labour will be the responsibility of the bidder. The operation is to be completed within the specified office hours i.e. between 1000 hrs and 1600 hrs. No work shall be permitted on Sundays or on closed holidays. Bidder shall not be allowed to pick and choose the materials. Empty bobbins are to be lifted as per the instruction of BNPM only. This material should not be sold to the employees of BNPM. Undertaking this regard has to be provided.

18. Allocation of Bobbins for sale:

After issuance of sale orders, empty bobbins shall be allocated for sale to the successful bidders (Purchasers) based on proportionate quantity of respective sale orders basis and against generation of empty bobbins. BNPM stores department shall provide the schedule to the successful bidders (Purchasers) accordingly and successful bidders (Purchasers) have to comply the same. However, BNPM reserves the right to change the allocated quantity in case it is related to ensure continuous production.

19. Compliance of security Norms:

BNPM is a security organization located in the premises of BRBNMPL and the Govt. of Karnataka declares the premises as Prohibited Area. Hence the contractor has to abide by the security rules of the Company. The contractor has to ensure the character and antecedent of the persons deployed. The contractor must be in a position to produce such documents whenever he is asked to do so. Details shall be furnished as per format when called for. The contractor has to issue printed photo identity card to its workers duly authenticated by the designated security officer of the Company. Contractor should apply for Gate Pass for labours, welding permission and material entry pass etc. as per approved format only, well in advance to avoid any delay in issue of Gate passes.

20. Contract Period:

One year from the date of issuance of order. However, BNPM reserves the right to short close the contract with 15 days' notice.

21. Free Delivery Time and Ground Rent:

Delivery must be taken as per the schedule provided by BNPM. If the purchaser is not able to lift the material within the free delivery period, he may request an extension. Such extensions are generally granted after levying a ground rent @ 1/2 (half) per cent of the sale value per day. But, in some genuine cases, the levy of ground rent may be waived as per the discretion of BNPM.

All the above terms and conditions have been read, understood and accepted by me.
