- 1. Tenders are to be uploaded on e-tendering portal <u>www.tenderwizard.com/BNP</u> only in Two part bid system.
- 2 i) **Part-I Prequalification Bid & Techno-commercial Bid**: Scanned copy of Documents towards eligibility criteria, Technical offer, GST, PAN, Bank details etc. along with all sections & annexures of this tender.

ii) Part II - Price Bid:

Price Bid shall be submitted through e-portal only, the price bid is liable for rejection if submitted in any other mode. Price Bid should be submitted as per the price bid format provided in Sec – XI, Price Schedule of this tender. Price Bid submitted in any other format will be liable for rejection. Price bids with conditions / Counter conditions are liable for rejection.

- 3. **Completion Schedule**: Successful bidder shall complete the work within 4 weeks from the date of issue of work order.
- 4. Items to be re-rubberised are to be collected from BNPM, Mysore and after re-rubberisation items are to be delivered at BNPM, Mysore.
- 5. **Security Deposit / Performance Security:** Not applicable
- 6. Parties who have been black listed /debarred by BNPMIPL/BRBNMPL/SPMCIL or any PSU or any Government Departments are not eligible for submission of this tender.
- 7. Bidder may visit BNPMIPL, before submitting the offer after taking due permission for visiting to understand the requirements.
- 8. No counter conditions shall be accepted.
- 9. Bidders are advised to write the page number on each page of the Techno Commercial bid documents submitted.
- 10. BNPMIPL reserves the right to accept the offer by and reject any or all bids or cancel the tender without assigning any reason thereof and does not bind itself to accept lowest quotations.
- 11. NSIC/UDYAM registration certificate is to be submitted for MSE bidders.
- 12. **Warranty:** The Re-rubberised roll shall be under warranty for 12 months from the date of receipt of material at BNPM Plant, Mysore. Warranty certificate to be provided along with the invoice.
- 13. **Static Balancing & Inspection:** Successful bidder has to submit static balancing report & pre despatch inspection report, if required BNPM representative may be present during static balancing.
- 14. BNPMIPL reserves the right to modify the quantity specified in this enquiry.
- 15. **Bid validity:** Price quoted should be valid for 120 days from the date of opening of the quotation.
- 16. The price by the bidder quoted should be fixed, firm till the completion of the order.
- 17. Evaluation of bids:
- (i) The technical bids shall be opened in the first instance and these bids shall be scrutinised and evaluated by the competent committee/ authority with reference to the qualification/ eligibility criteria prescribed in the tender document. Subsequently, in the second stage the financial bids of only techno commercially acceptable offers as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.

- (ii) <u>All responsive tenderers shall be evaluated as per the</u> eligibility criteria and <u>terms & conditions</u> <u>of the tender.</u>
- (iii) **Price Evaluation criteria:** Price evaluation to determine L-1 status shall be done on the basis of overall effective price i.e. Total Price quoted by the bidder less input GST. BNPM reserves the right to reject the bids that may be considered unviable from the standards to be maintained merely because someone has quoted low and will not be automatically qualified to become in the select list. In case of tie in quoted price bid between / among bidders, the bidder having higher net worth in the last financial year shall be declared lowest between / among them. Where there is a discrepancy between the amounts in words and figures, the amount in words will govern. Where there is a discrepancy between the unit rate and the total price, the unit rate as quoted will govern.
- (iv) Bidder has to quote GST rate as per the HSN/SAC code provided in Section V: Price Schedule. In case of any mismatch in HSN/SAC code with respect to offered product/service, same shall be decided in consultation with the successful bidder.
- 18. Payment of GST is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the quotations. If no indication regarding GST is recorded in the quotation, the GST will be considered as included. Bidder should be able to pass on input tax credit.
- 19. **Completion period:** Re-rubberised, grinded & finished items should be delivered at BNPM,Mysore within 4 weeks of issuance of order.
- 20. **Liquidated Damage:** Failure to supply the material/service within the stipulated completion period shall entitle BNPM to impose liquidated damages without assigning any reasons @ 0.5% (Half Percent) of the total value of the order as LD per week or part thereof subject to a maximum of 10% (Ten Percent).
- 21. **Risk Purchase:** If the successful bidder fails to abide by the terms and conditions of the tender/contract /LOI or fails to provide service as per the tender terms / scope of work / any time repudiates the contract / poor performance / violation(s) of any clause(s) of the agreement or for any bad act of selected bidder / fail to enter into contract agreement within stipulated time , the purchaser(BNPM) will have the right to do the following:
 - i. Termination of the contract
 - ii. Render service from other agencies at the risk and cost of the successful bidder. The cost difference between the alternative arrangement and existing contract value wherein default has been made will be recovered from the successful bidder along with the other incidental charges.
 - iii. In case of rendering service through alternative sources, if price is lower than the existing contract value wherein default has been made, in such case no benefit on this account will be passed on to the successful bidder.
 - iv. Holiday Listing/ Debarment/Blacklisting as per the discretion of BNPM.
- 22. **Payment terms:** 100% (Hundred Percent) within 30 (Thirty) days on completion of the work i.e delivery of re-rubberised items at BNPM, Mysore and acceptance of same by BNPM officials.
- 23. **Settlement of Disputes through Arbitration:** All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after their completion except accepted matters shall be settled through arbitration process as per the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysore, Karnataka
- 24. **Legal Jurisdiction:** The Courts of Mysore (Karnataka State) shall alone have jurisdiction to decide on any legal matter of dispute whatsoever arising out or in respect of the contract.

25. **Force Majeure:** In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by BNPM in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.

26. Termination of Contract for Default:

Without prejudice to any other remedy for breach of contract, such as removal from the list of registered supplier, by written notice of default sent to the successful bidder, the contract may be terminated in whole or in part:

- i) If the successful bidder fails to deliver any or all of the items/services within the time period(s) specified in the contract, or any extension thereof granted; and
- ii) If the successful bidder fails to perform any other obligation under the contract within the period specified in the contract or any extension thereof granted.
- 27. **Termination for Convenience (Foreclosure) Clause:** BNPM reserves the right to terminate the contract, in whole or in part for its (BNPM's) convenience, by serving written notice on the successful bidder at any time during the currency of the contract. The notice shall specify that the termination is for the convenience of BNPM. The notice shall also indicate inter-alia, the extent to which the successful bidders's performance under the contract is terminated, and the date with effect from which such termination will become effective.
- 28. **Rights of Rejection:** BNPMIPL reserves the right to reject any or all the applied bids without assigning any reason whatsoever. The enquiry can be rejected on national security grounds.
- 29. **Preference for Micro and Small Enterprises (*MSEs):** Public procurement policy for Micro and Small Enterprises (MSEs) order, 2012 as notified by Govt. of India (GOI) along with its amendments as available in www.msme.gov.in shall be applicable to this tender.
- 30. **Compensation for damages:** In case any damage is caused to the material as provided by BNPMIPL for re-rubberisation , grinding , finshing work due to negligence, carelessness or inefficiency of staff of the successful bidder, the successful bidder shall be responsible to make good the loss. BNPMIPL shall have the right to adjust the damage / loss suffered by it or / and to charge penalty as decided by BNPMIPL. Decision of BNPMIPL in this respect shall be final and binding on the successful bidder.
- 31. **Successful bidder's responsibility:** The successful bidder shall provide everything necessary for the proper execution of the order according to the intent and meaning of the Scope of Work and details taken together whether the same may or may not be particularly shown or described therein provided that the same can reasonably be inferred there from. If the successful bidder finds any discrepancy in the Scope of Work & details, then shall immediately and in writing refer the same to the BNPMIPL who shall decide which is to be followed.
