**SECTION I**  
**NOTICE INVITING TENDER**

1. Bank Note Paper Mill India Private Limited (BNPM) is a joint venture company between Bharatiya Reserve Bank Note Mudran Private Limited (A wholly owned subsidiary of Reserve Bank of India) and Security Printing and Minting Corporation of India Limited (100% owned by Government of India), incorporated for setting up & manufacturing of bank note papers at Mysore.
2. E-bids are invited by BNPM from eligible & financially sound bidders for Sale of Filter Press Cake / Primary Sludge "As -Is- Where- Is" basis at BNPM, Mysore - 570003.
3. **Note: Bidders who had already quoted their maximum annual filter press cake sludge disposal capacity at H1 rate against tender no BNPM/OTE/200/2024-25, date 18.07.2024 are being restricted to participate in this tender, and even if quoted their bid i.e unsolicited bids will be rejected.**

- b. Aspiring Bidders/Contractors who have not registered in e-tendering should register through the website E - Tendering ([www.tenderwizard.com/BNP](http://www.tenderwizard.com/BNP)) for participating in the Online Tenders. **The registration charges will be Rs. 500/- plus applicable taxes (per year) which needs to be paid through electronic mode only. Tender processing fee is Rs.1,000/- plus applicable Taxes.**

- d. The NIT along with tender documents will be accessible in the e-Tendering website (viz [www.tenderwizard.com/BNP](http://www.tenderwizard.com/BNP)).
- e. Class III Digital Signature Certificate (DSC) is mandatory to participate in e-Tenders. Participating bidders/Contractors have to make sure that they have the valid DSC. If not, they can procure from any of the RAs approved by CCA.
- f. Bidders/Contractors should upload and attach all the Scanned copies of technical documents/certificates in e-tendering website [www.tenderwizard.com/BNP](http://www.tenderwizard.com/BNP) pertaining to their eligibility criteria mentioned in the NIT, failing which, the bid will not be considered.
- g. Online bids are to be submitted through e tender portal ([www.tenderwizard.com/BNP](http://www.tenderwizard.com/BNP)) only.  
Against receipt of the following notification through email from tenderwizard portal, bidder must resubmit the bid even if the bidder have already submitted the bid through tenderwizard portal.

***Notification: If you have already submitted the tender, then ensure that you resubmit the tender. Else, your bid may be liable to be auto disqualified by the system. And service provider holds no responsibility for the same. In case, you are yet to submit the tender, then please ensure that you submit it before the tender closing time.***

Submission / resubmission of the bid is the responsibility of the bidders only. Bidder should check and confirm at their end regarding the submission/ resubmission of their bid till the due date & time of bid submission. BNPM / Keonics/ Tenderwizard will not be responsible for non-submission/ non-resubmission of any bid.

4. **Eligibility Criteria:** The prospective bidders should submit the documents as mentioned below.
- a. Proof of registration i.e., valid GST and PAN.
  - b. The bidder shall submit a declaration (in letter head) that, they are in to the business of manufacturing of paper board (soft/ hard board) and if filter press cake is to be used for other than manufacturing of paper boards, then the bidder will take prior consent from BNPM by submitting detail disposal procedure.
  - c. The bidder shall have **valid authorization or valid consent for operation issued by KSPCB/CPCB/respective SPCB for reusing the filter press cake sludge / primary sludge/equivalent effluent.** Bidder has to submit the aforementioned valid authorization or consent for operation copy. (Validity means valid as on date of opening of the tender).
  - d. **In case the bidder has applied for authorization or consent for operation at KSPCB/CPCB/respective SPCB then the respective application may be submitted along with their bid.**
  - e. **In case the bidder is willing to apply for authorization or consent for operation at KSPCB/CPCB/respective SPCB, then bidder has to submit a declaration in company letter head that within 3 months from the date of issuance of the order /contract (if issued) they will submit the required authorization or consent issued by KSPCB/CPCB/respective SPCB.**
  - f. **Bidder should have the maximum annual capacity of at least 2880 MT (i.e tendered quantity) for disposing filter press cake sludge. This capacity is to be mentioned under Sec II, List of Material.**
5. **General Criteria: Bidder to submit following declaration:**
- i. The bidder assumes responsibility for and shall indemnify, defend and hold harmless the BNPM, their respective officers, directors, personnel, agents, employees, from and against all losses, liabilities, claims, costs, expenses, taxes and assessments including penalties, punitive, damages, attorney's fees and court costs which are or may be incurred with respect to any breach by the bidder of its obligations under this the contract/ order ( if issued ) or for which the contractor has assumed responsibilities under the contract/ order (if issued).
  - ii. After buying the filter press cake sludge/ primary sludge from the Company, kraft board/ paper board manufacturing, if the sludge is to be used for any other

purpose prior consent shall be obtained from BNPM. Required approval from KSPCB / CPCB/ respective SPCB if any shall be obtained by the contractor.

- iii. Loading, transportation, unloading, reprocessing shall be carried out by the bidder Ex-works BNPM, Mysore basis and as per KSPCB/CPCB/respective SPCB guideline. Any deviations during the process shall be solely attributed to the bidder. Bidder required to abide to the guidelines prescribed by the KSPCB/CPCB/ respective SPCB.
  - iv. The transportation shall be in accordance with the existing rules and guidelines by the respective pollution control board and in accordance with the rules made by central Govt under motor vehicles act 1984. The transportation vehicle shall have along with it, the **Fitness certificate of the vehicle**,
  - v. The responsibility of the safe transport of the sludge shall be sole responsible of the receiver.
  - vi. In case of transportation of sludge for final disposal to a facility existing in a State other than the State where the sludge is generated, the sender shall obtain '**No Objection Certificate**' from the **State Pollution Control Board of both the States** with whom the buyer is registered, failing which buyer will be responsible for the consequences and BNPM shall take further action as deemed fit.
6. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected.
7. Tenderers should quote their prices and rates both in figures and in words. No blank spaces shall be left. All erasures and corrections made while filling up the tender shall be initiated by the tenderer.
8. The tender shall remain open for acceptance for a period of 120 days from the date of opening of the tender.
9. **EVALUATION CRITERIA:**
- a. At first stage, techno-commercial bid will be opened and evaluated by the competent committee/ authority with reference to the parameters prescribed in the tender document. Subsequently, in the second stage the financial bids of only technically acceptable offers as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to the qualified bidders to enable them to attend the same.
  - b. The Unit Rate (Effective price without GST, refer price bid) quoted by the bidders in the price bid shall be considered for determining the H1 bidder. The bidders have to

indicate in the price bid the maximum quantity of sludge that can be disposed off by the bidder.

c. **Parallel Contract:**

The manner of deciding the relative share of highest bidder (H1) and the rest of the bidders will be splitted in the ratio of 70:30, respectively.

However, H1 price should be reasonable. If it is not reasonable, negotiation with the H1 bidder may be carried out. The following guidelines are to be considered while opting for parallel contracts:

- i. H1 should be awarded at least 70% percent of the tendered quantity as mentioned above.
  - ii. For the rest of the tendered quantity, the highest rate (H1 rate) accepted will be counter offered to the H2 bidder. On acceptance of the counter offer, the order will be placed on H2 for the rest 30% percent of the tendered quantity. In case of non-acceptance of the counter offer by the H2 bidder, a similar offer shall be made to H3 and H4, and so on.
  - iii. If after placement of order to all the eligible bidders there is any quantity left out then same may be counter offered to H1 bidder with same highest rate (H1 rate). If any quantity is balance thereafter then same may be counter offered to H2, H3, H4 bidders with same highest rate and so on.
- d. In case of two or more bidders quote the same H1 rate( i.e in case of tie), then based on the sludge lifting capacities indicated by the bidders in the bid document, the bidder having highest sludge lifting capacity shall be considered as H1 bidder and accordingly the aforementioned guidelines mentioned under point 9(c) will be followed.

This will be under sole discretion of BNPM.

10. The acceptance of the tender will rest with BNPM, who does not bind himself to accept the highest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason thereof.
11. BNPM also reserves the right to allot the order partly or wholly to single or different Tenderer. BNPM reserves the right to reject any offer including the highest one if the same is not conforming to its norms. The decision of BNPM in this regard will be final.
12. **Discrepancy in Prices:**
  - i. If, in the price structure quoted by a tenderer, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless BNPM feels that the tenderer has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.

- ii. If, there is an error in total price, which has been worked out through addition and/ or subtraction of subtotals, the subtotals shall prevail and the total corrected; and
- iii. If, there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail.
- iv. If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the tenderer by registered/speed post/email. If the tenderer does not agree to the observation of BNPM, the tender is liable to be ignored.

6. **Earnest Money Deposit (EMD):** Interest free EMD of Rs 20,000/- (Rupees Twenty Thousand only). The EMD shall be paid through online at e-tender portal ([www.tenderwizard.com/BNP](http://www.tenderwizard.com/BNP)). The tender without EMD shall be liable for rejection. Submission of EMD is exempted for Micro and small enterprises (MSEs) as per the Public Procurement Policy for MSEs Order, 2012. MSEs should be registered and also will continue to remain registered during the tender validity period with District Industries Centre (DIC) or Khadi and Village Industries Commission (KVIC) or Khadi and Industries Board (KVIB) or Coir Board or National Small Industries Commission (NSIC) or Directorate of Handicrafts and Handlooms or UDYAM or Any other body specified by Ministry of MSME. For EMD waiver of MSE bidders, valid UDYAM registration certificate as applicable is to be submitted along with Annexure A (Bid Security Declaration).

For Start-up bidders EMD may be exempted as per the office memorandum no. F/20/2/2014-PPD(Pt) of MOF dated 25.07.2017. Start-ups should be registered with DPIIT and should submit certificate of recognition as issued by DPIIT along with Annexure A (Bid Security Declaration).

Non-MSE, Non-start-up bidders have to submit EMD.

For successful bidders' interest free EMD amount will be released on submission of security deposit amount, if security deposit is submitted in form BG, then EMD will be released after confirmation of BG from respective Bank. For unsuccessful bidders' interest free EMD shall be released after finalization of the sale order. EMD will be forfeited against bid withdrawal after tender opening.

EMD should be valid for 45 days beyond bid validity.

13. **Performance security/Security Deposit (SD):** Within ten (10) days after the issue of notification of award (i.e PO/WO/LOI whichever is earlier) by BNPM, the successful bidder shall furnish performance security to BNPM for an amount equal to ten (10) per cent (%) of the total value of the contract with validity up to 60(sixty) days beyond the date of completion of contract period of one year.

Performance security may be furnished in the form of:

- i. Account payee demand draft
- ii. Unconditional Bank Guarantee issued and confirmed from any scheduled commercial bank in India



- iii. Fixed deposit receipt (FDR) from a scheduled commercial bank in India, lien marked to Bank Note Paper Mill India Pvt Ltd, Mysore
- iv. Online payment in an acceptable form.
- v. Insurance surety bond

If the successful bidder fails to resume/complete the work within stipulated time, security deposit of such bidder shall be forfeited. SD shall be interest free. **If the successful bidder fails to submit the Security Deposit & does not lift the sludge within 2 months of order placement, then BNPM has the right to cancel the order & debar that bidder.**

Performance security is to be suitably extended for any extension of the contract period.

14. **Terms of Sale:** Successful Bidder has to submit advance amount which is equivalent to the value of the sludge to be lifted preferably 3 days before lifting the material.

The advance payment should be made vide electronic transfer / Deposit to the Bank Account of Bank Note Paper Mill India Pvt Ltd.

Successful Bidder shall be allowed to lift the material only if the advance amount is equivalent to the sludge to be lifted.

15. **Site Visit/ Inspection:** To assess the state/ conditions of sludge materials and to determine the price to be quoted, the Bidder may visit the project site on or before due date of submission of bid and to get acquainted with the conditions at the site. Those who are already using filter press cake sludge generated at BNPM, may not require to visit, however it will be at their own discretion. Prior intimation to BNPM, Mysore may be provided before visiting BNPM, Mysore site vide email at [scm.tender@bnpmindia.com](mailto:scm.tender@bnpmindia.com). The visiting personnel should carry original aadhaar card / driving license.

16. **Duration of Contract & Completion Time:** The contract will remain valid for one year from the date of issuance of order. This contract is extendable by yearly renewal basis with same terms & conditions, scope of work and same finalized rate for another 2 years on yearly extension basis against satisfactory performance. Work for lifting the available sludge materials shall be started within 15 working days of issue of Sale Order and lifting of the available sludge should be finished within 60 days from the issue of Sale Order. The sludge materials available thereafter shall be lifted as and when available and as per the schedule provided by BNPM for disposal up to the completion of contract period.

17. **Tenders for Disposal of Sale of Filter Press Cake/ Primary Sludge:**

The tender is for Sale of Filter Press Cake/ Primary Sludge. Details of sludge for sale including Description, Lot Size would be given in the "List of Materials".

- a. "As Is; Where Is" Basis of This Sale:
- b. This sale of Sludge is strictly on "As Is; Where Is" basis. Tenderer must satisfy himself on all matters with regard to quality, quantity; nature of stores etc., before tendering as no complaint or representation of any kind shall be entertained after the sale contract is concluded.
- c. The description of lot (if applicable) in the particulars of sale has been given for the

purpose of identification thereof only and the use of such description shall not constitute the sale thereof to be sale by description and no sale shall be invalid by reason of any defect or deviation or variation in any lot or on account of any lot not being exactly described and the purchaser shall not be entitled to claim any damage or compensation whatsoever on account of such fault, error in description, weight or the like.

- d. All quantities of sludge whether by weight or measurement mentioned in the Tender notice are only approximate and should the quantity, on actual weight or measurement basis as the case may be and whenever delivered on such basis, works out less than the advertised and /or projected quantity, the BNPM shall not under any circumstances be liable to make good any such deficiency. BNPM reserves right to increase or decrease the quantity of any item or items or terminate the contract at any stage by giving one week's notice. No claim whatsoever shall lie against the BNPM on account of such termination of the contract or variation in the quantity.
- e. BNPM shall have the right to remove certain items which it feels were not intended for sale but were inadvertently made a part of the lot offered for sale lying at the premises or were joined or attached to the material offered for sale.
- f. Any person giving offer shall be deemed to have made himself/herself fully conversant with the Terms and Conditions of the Tender Sale, as well as the location and condition of the materials being sold and shall be deemed to have agreed to all the stated terms and conditions herein under.

**18. Procedure for Disposal of Filter Press Cake/ Primary Sludge:**

On finalization of tender, a sale order will be issued to successful bidder by BNPM. The existing available quantity for lifting the available sludge materials shall be started within 15 working days of issue of Sale Order which has to be lifted within 60 days from the date of issue of sale order.

The contractor shall make advance payment as mentioned above for the material to be lifted. Bidder shall arrange vehicle, if any, Tools & tackles /materials required & labour for collection from various places in the site, loading, transportation at his own cost. The safety of the labour will be the responsibility of the bidder. The operation is to be completed within the specified office hours i.e. between 1000 hrs and 1600 hrs. No work shall be permitted on Sundays or on closed holidays.

After buying the sludge from the Company, the same should not be sold to the employees of the Company and the same should be used for manufacturing of paper board at your company / other authorized company.

If the successful bidder is a manufacturer of Paper Board then BNPM may visit the plant of the bidder to inspect manufacturing of paper board using Filter Press Cake Sludge. All rules & regulations imposed by Pollution Control Board from time to time for manufacturing of Paper Board by using Filter Press Cake Sludge are to be strictly followed by the successful bidder.

19. **Tender Evaluation and award of work:** Tenders will be evaluated as per the terms and based on responsiveness taking into account all relevant factors. While the H-1 will generally be the criteria, BNPM reserves the right to reject any offer including the H-1 if the same is not conforming to its norms. The decision of BNPM in this regard will be final.
20. **Compliance of security Norms:**  
BNPM is a security organization located in the premises of BRBNMPL and the Govt. of Karnataka declares the premises as Prohibited Area. Hence the contractor has to abide by the security rules of the Company. The contractor has to ensure the character and antecedent of the persons deployed. The contractor must be in a position to produce such documents whenever he is asked to do so. Details shall be furnished as per format when called for. The contractor has to issue printed photo identity card to its workers duly authenticated by the designated security officer of the Company. Contractor should apply for Gate Pass for labours, welding permission and material entry pass etc. as per approved format only, well in advance to avoid any delay in issue of Gate passes.
21. **Variation of Qty:**  
The quantity mentioned in the Tender is approximate only. BNPM has the right to vary the quantity as per requirement at any stage of the contract period after issuance of order.
22. **Termination of Contract & Placement of order to another bidder:**  
If after placement of order to a party, it is observed that the party is not complying the order terms, then BNPM has the right to terminate the order with 1 month notice period ,with forfeiture of Security Deposit (as applicable) and issue holiday notice to the party. Further BNPM may accordingly place order to other bidders matching the H1 price for disposal of sludge.
23. **Preference to MSME, MII:**  
As per PPP-MSE and PPP-MII order issued by MoMSME, GOI and DPIIT, MoCI, GOI respectively and subsequent orders/policies/notifications issued. For availing purchase preference bidder to claim under techno commercial bid and submit relevant documents/ certificates as applicable under aforementioned orders/policies/notifications.
24. **Divisibility, splittability of the contract:** The contract is splittable as mentioned under evaluation criteria however it is non-divisible.
25. **Exemption for eligibility criteria for MSME, Start up towards eligibility criteria (Turnover, Experience):** Exemption is not applicable.
26. **Non-performance of the successful bidder:**  
Successful bidder should adhere the schedule of lifting of the sludge as provided by BNPM time to time. During the execution of the contract if the performance of the

bidder is found unsatisfactory then BNPM has the right to (i) Terminate the contract (ii) Forfeit the security deposit amount (iii) Debar/ Blacklist the bidder.

**27. Performance in executing previous contracts:**

Performance of the bidders in executing the previous orders will be considered for techno commercial evaluation. Any non-performance in executing the previous contracts may lead to techno commercial disqualification as per the discretion of BNPM, Mysore.

**28. Default by buyer:** Sludge sold but not removed within the specified date will become the property of the seller and it will have the right to dispose of such Goods in any manner as he deems fit without any notice.

**29.** BNPM reserves right to increase or decrease the quantity of sludge or terminate the contract against default by buyer at any stage by giving one week's notice. No claim whatsoever shall lie against the BNPM on account of such termination of the contract or variation in the quantity. BNPM shall have the right to remove item which it feels were not intended for sale but were inadvertently made a part of the sludge or of the lot offered for sale lying at the premises or were joined or attached to the sludge offered for sale. Tenderers desirous of purchasing and participating in the tender must visit the site before submitting the offer, after taking due permission from the concerned Stock Holders. The Tenderers submitting the offers shall be deemed to have visited the site and acquainted themselves thoroughly with materials intended for sale in all respect. Any person giving offer shall be deemed to have made himself fully conversant with the Terms and Conditions of the Tender Sale, as well as the location and condition of the materials being sold and shall be deemed to have agreed to all the stated terms and conditions herein under.

**30. Conflict of interest:** A bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to anti-competitive practice to the detriment of BNPM interests. The bidder found to have a conflict of interest shall be disqualified after giving a reasonable opportunity of being heard. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- a. they have controlling partner (s) in common; or
- b. they receive or have received any direct or indirect subsidy/financial stake from any of them; or
- c. they have the same legal representative/agent for purposes of this bid;
- d. they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another bidder; or
- e. Bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one bid will result in the disqualification of all bids in which the

parties are involved. However, this does not limit the inclusion of the components/sub-assembly/assemblies from one bidding manufacturer in more than one bid.

- f. In cases of agent's quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer. There can be only one bid from the following:
  - 1. The principal manufacturer directly or through one Indian agent on his behalf; and
  - 2. Indian/foreign agent on behalf of only one principal.
- g. A Bidder or any of its affiliates participated as a consultant in the preparation of the design or TS of the contract that is the subject of the bid;
- h. In case of a holding company having more than one independently manufacturing units, or more than one unit having common business ownership/management, only one unit should quote. Similar restrictions would apply to closely related sister companies. Bidders must proactively declare such sister/ common business/ management units in same/ similar line of business.
- i. In the event of the bidder having any conflict of interest, such bidder is obligated to disclose the same to BNPM. Failure to do so will disqualify the bidder.

**31. Obligations by bidders:**

- a. All bidders are obliged under the CIPP (Code of integrity of public procurement) to suo moto proactively declare any conflict of interest (coming under the definition mentioned above under point no 30, pre-existing or as and as soon as these arise at any stage) in any procurement process or execution of contract. Failure to do so would amount to violation of this Code of Integrity; and
- b. Any bidder must declare, whether asked or not in a bid document, any previous transgressions of such a Code of Integrity with any entity in any country during the last 3 (Three) years or of being debarred by any other Procuring Entity. Failure to do so would amount to violation of this code of integrity;
