**1. Scope of work:**

Providing the certification for structural stability of factory building by Chartered Engineer i.e. Bank Note Paper Mill buildings and other components in **Form No. 1 A** as per the factory act & Karnataka rules.

- i) Engineer or the firm should have executed similar nature of work for any industrial organizations.
- ii) Stability testing shall be carried out for 1 factory building. (Mini Press Building)
- iii) The job shall include the followings but not limited, however consultant or engineer has to perform all the activities/tests etc. if required;
  - a) Detail study of buildings, structure, foundations etc. as per drawings and observations will be made for the present status of buildings/structures etc.
  - b) Testing of structural members may be carried out wherever required on random basis.
  - c) Separate stability certificates for each building shall be submitted by the engineer or consultant,
  - d) Necessary laboratory test may be carried out as per the statutory authority requirement
- iv) The consultant shall submit the stability certificate as per requirement of statutory rules and regulations of factory act, Karnataka.
