- Part-I Prequalification Bid & Techno-commercial Bid: Scanned copy of Technical offer (Catalogue / Brochure etc.), GST, PAN, Bank details etc., along with all sections & annexures of this tender.

Price shall be furnished through e-portal only.

Price offer submitted in any other format shall be liable for rejection.

- 3. **Delivery Schedule**: The service is to be carried out at BNPMIPL as per the directives of BNPM representative(s) for the occasion of Dussehra. The lights should be kept in working condition on buildings for a period of 7 days after fixing (as per instructions of BNPM representative). Fixing of lights should be completed within a period of 3 days from date of intimation & the same shall be removed after 7 days from date of complete fixing of lights (or) as per mutually agreed timelines between BNPM & Successful bidder (if any). Time is the essence of this contract. No delay in delivery shall be acceptable and entertained.
- 4. **Delivery Terms:** It is the responsibility of Service provider to arrange packing & forwarding, transportation, transit insurance, Boarding & Lodging expenses for manpower, tool charges and any other charges to complete services on F.O.R BNPM, Mysuru basis only.
- 5. Warranty: Not Applicable
- 6. **Security Deposit / Performance Security:** Not Applicable

- 14. All drawings sketches and samples, if any, sent along with this enquiry must be returned along with quotations duly signed.
- 15. All supplies are subject to inspection and approval before acceptance. Manufacturer/ supplier warranty certificates and manufacturer/Government approved lab test certificate shall be furnished along with the supply, wherever applicable.
- 16. The BNPMIPL reserves the right to modify the quantity specified in this enquiry.
- 17. The prices quoted should be firm till the supplies are completed. Please quote the rates in words and figures. Rates quoted should be door deliver basis at destination including all charges otherwise the quotation is likely to be rejected. Prices quoted for free delivery at destination (i.e., Mysore) will be given preference. If there is no indication regarding the F.O.R, in the quotation, then it will be considered as F.O.R destinations. Price quoted should be net and valid for a minimum period of three months from the date of opening of the quotation.
- 18. (i) The technical bids shall be opened in the first instance and these bids shall be scrutinized and evaluated by the competent committee/ authority with reference to the parameters prescribed in the tender document. Subsequently, in the second stage the financial bids of only technically acceptable offers as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.
  - ii) The method of evaluation of bidder for awarding the contract shall be on the basis of overall lowest bidder (L-1) (i.e. considering all the line items together) for delivery up to BNPM, Mysore.
  - (iii) All responsive tenderers shall be evaluated as per the terms & conditions of the tender. The basis for arriving at the lowest responsive bidder shall be as per the price quoted for landed cost at Mysore including GST, Packing & Forwarding charges, Freight, Insurance and any other charges etc. and input credit shall be deducted to arrive at the effective price. Effective price shall be considered for arriving at the lowest responsive bidder.
  - (iv) Bidder has to quote GST rate as per the HSN code provided in Section XI: Price Schedule. In case of any mismatch in HSN code with respect to offered product, same shall be decided in consultation with the L-1 bidder.
- 19. In case the items in the enquiry are covered by any rate contract or running contract finalized by the DGS&D or any other State or Central Government, is should be specified in your quotation and accepted contract rates should also be mentioned. It should be confirmed whether you could supply at the RC rates outside rate contract.
- 20. Payment of GST is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the quotation. If no indication regarding GST is recorded in the quotation, the GST will be considered as included.
- 21. Delivery period required for supplying the material should be invariably specified in the quotation.

- 22. In case your quotation is accepted and order is placed on you, the supply against the order should be made within the period stipulated in the order. BNPMIPL reserves the right to recover any loss sustained due to delayed delivery by way of penalty. Failure to supply the material within the stipulated period shall entitle BNPM to impose liquidated damages without assigning any reasons @ 0.5% (Half Percent) of the total value of the item covered in order as LD per week or part thereof subject to a maximum of 10% (Ten Percent) which you unconditionally and expressly agree to unless extension is obtained in writing from the office on valid ground before expiry of delivery period.
- 23. If the deliveries are not maintained and due to that account BNPM is forced to buy the material at your risk and cost from elsewhere after due notice to you, the loss or damage that may be sustained thereby will be recovered from the defaulting supplier.
- 24. **Payment terms**: 100% payment shall be made against completion of work and on submission of required documents at BNPM, Mysuru. Statutory deductions as applicable will be deducted from the gross bill amount. Bank account details shall be submitted along with the Invoice.
- 25. **Settlement of Disputes through Arbitration:** All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after their completion except accepted matters shall be settled through arbitration process as per the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysore, Karnataka.
- 26. **Legal Jurisdiction:** The Courts of Mysore (Karnataka State) shall alone have jurisdiction to decide on any legal matter of dispute whatsoever arising out or in respect of the contract.
- 27. **Force Majeure:** In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by BNPM in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.
- 28. **Fore-Closure Clause:** If at any time during the continuation of this contract, the use of material ordered in this contract is completely banned or due to drastic change in Government policy its use as, raw material is discontinued or is declared hazardous to public health or cause rising to civil commotion, epidemics, wide-spread strikes and 21 days' notice of such eventualities is given by purchaser to the seller, the seller without any right to enforce the contract, will agree

to the fore-close the performance of balance portion of this contract and in that event no claim for damages or loss will be lodged against the purchaser.

- 29. **Rights of Rejection:** BNPMIPL reserves the right to reject any or all the applied bids without assigning any reason whatsoever. The enquiry can be rejected on national security grounds.
- 30. **Preference for Micro and Small Enterprises (MSEs):** Public procurement policy for Micro and Small Enterprises (MSEs) order, 2012 as notified by Govt. of India (GOI) along with its amendments as available in <a href="https://www.msme.gov.in">www.msme.gov.in</a> shall be applicable to this tender.

- a. The list of requirements provided above are to be installed at BNPM, Mysuru and should be kept in working condition for a period of 7 days on the occasion of Dussehra (Nadahabba) in its buildings like Administrative Building, Gate Complexes, Technical Building, Pulping Plant, Garden area etc.
- b. Tentative period of installation shall be during 3<sup>rd</sup>/4<sup>th</sup> week of October 2023. Exact dates shall be confirmed by BNPM after order placement to the successful bidder.
- c. The list of above mentioned requirements are to be supplied on rental basis for a period of 7 days as per intimation provided by BNPM.
- d. The lights shall be installed by contractor within a period of 3 days from date of receipt of intimation from BNPM representative.
- e. The lights should be in good working condition. In case of any issues, the same shall be made correct (or) be replaced immediately for effective lighting. In case the lights have not been replaced after due intimation, payment for such non-working lights shall be withheld retrospectively for such date.
- f. 1 No. of LED Serial Light set should be of minimum 8 meters in length.

- h. Electrical power source shall be provided by BNPM to successful bidder. However in case of any requirement of electrical cable extensions to reach power source, the same shall be in scope of contractor.
- i. Contractor shall ensure that all lights are in good working condition on daily basis prior to start of lighting.
- j. Dismantling of installed lights after completion of required period shall be done by contractor.

  - b) A subsidiary controlled through entities incorporated, established or registered in such a country, or
  - c) An entity substantially controlled through entities incorporated, established or registered in such a country, or
  - d) An entity whose beneficial owner is situated in such a country; or
  - e) An India (or other) agent of such an entity; or
  - f) A natural person who is a citizen of such a country; or
  - g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.
- IV) The beneficial owner for the purpose of (III) above will be as under :-
  - 1) In case of a company or limited liability partnership, the beneficial owner is the natural person (s), who, whether acting alone or together, or through one or more judicial person, has a controlling ownership interest or who exercise control through other means.

Further explanation:

- a) "Continuing ownership interest" means ownership of or entitlement to more than twenty five per cent of shares or capital or profits of the company;
- b) "Control" shall include the right to appoint majority of the director or to control the management or policy decision including by virtue of their shareholding or management rights or shareholder agreements or voting agreements;
