1. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the

completed financial years after the date of constitution shall be taken into account for this criteria.

- 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

ii. Terms of Payment:

100% amount of the invoiced value shall be released within 10 from the date of receipt and acceptance of goods by the consignee at destination and on production of all required documents by the supplie r.

NEFT/RTGS details shall be furnished along with the Original Invoice.

iii. Delivery Schedule:

Successful bidder shall start the delivery of material within 30 days from the date of PO as per delivery schedule promulgated by BNPM. Monthly/Quarterly delivery schedule shall be issued to successful bidder.

iv. Performance Security:

Within twenty-one days after the issue of notification of award by BNPM, the supplier shall furnish perf

ormance security to BNPM for an amount equal to **Five per cent (5%)** of the total value of the contra ct, valid up to sixty days after the date of completion of all contractual obligations by the supplier. Per formance security may be furnished as,

- a. Insurance Surety Bonds (or)
- b. Account Payee Demand Draft (or)
- c. Fixed Deposit Receipt from a commercial bank lien to Bank Note Paper Mill India Pvt. Ltd. (or)
- d. Bank Guarantee (including e-Bank Guarantee) issued/confirmed from any of the commercial ban k in India in an acceptable form. (or)
- e. Online payment

v. Liquidated Damages (LD):

If the supplier fails to deliver any or all of the goods within the time frame(s) incorporated in the contr act, BNPM shall without prejudice to other rights and remedies available to BNPM under the contract deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% (Half) percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to maximum deduction of the 10% of the delayed goods' contract price(s).

vi. Shelf Life:-

- i.) Shelf life Period for Sodium Hypochlorite Solution shall be minimum 06 months from the date o f supply to BNPM, Mysore.
- ii.) In case of any claim arising out within the shelf life time, BNPM shall promptly notify the same in writing to the supplier.
- iii.) upon receipt of such notice, the supplier shall, within a reasonable span of time (or within the p eriod), replace the defective chemicals or parts thereof, free of cost, at the ultimate destinatio n. The supplier shall take over the replaced chemicals after providing their replacements and no claim, whatsoever shall lie on BNPM for such replaced chemicals thereafter.
- iv.) In the event of replacement of chemicals during the shelf life period, the shelf life for the repla ced chemicals shall be extended to a further period of minimum six months from the date such replaced chemicals starts functioning to the satisfaction of BNPM.
- v.) If the supplier, having been notified, fails to replace the chemicals within a reasonable period (i.e.15 days), BNPM may proceed to take such remedial action(s) as deemed fit by BNP M, at the risk and expense of the supplier and without prejudice to other contractual rights an d remedies, which BNPM may have against the supplier.

vii. Packaging & Marking:

Only in 1000 litre Intermediate Bulk Container (IBC) with 50 NB Flange (to suit ANSI B16.5, 150 class) after valve at outlet. The packing shall be as per requirement of BNPM and the used IBC shall be take n back by the vendor after use in BNPM for reuse. There should be proper indication on the IBC regarding the content. The packing shall bear legibly and indelibly the following information: a) Name and Grade of Material b) Name of Manufacturer c) Weight of material in kg d) Month and Year of Packing. e) Shelf Life f) Batch Number

A copy of the Safety Data Sheet (SDS) shall be sent by the bidder along with the first supply and when ever required by BNPM

viii.Rejection Criteria:

The material will be accepted in the range of 100 - 150 gpl. Even though 125 gpl is the minimum requirement lower gpl material will be accepted on pro-rata deduction on landed cost. If gpl is on higher side no additional payment would be made to the bidder. If available chlorine (as Cl) is less than 10 % percent by mass by volume the material would be rejected outright.

The rejected material shall be taken back within 7 days at the cost and risk of the supplier and replace ment should be made within 10 days from the date of intimation. If the rejected material is not taken out of BNPM premises by the supplier within 07 days from intimation, BNPM reserves the right to disp

ose off the chemical at the risk and expense of the supplier.

ix. Quality:

The supplier shall supply the material as per the technical specification. The material supplied will be inspected at our factory. Quantity as ascertained on receipt of above material at our site will be treated as quantity supplied wherever the package/material are received intact. As regards quality, our laboratory analysis report will be final and our decision on acceptance or rejection will be final and binding on supplier.

x. Calculation for pro rata deduction (in case of supply of material in the range of 100 to 12 5gpl)

xi. Conflict of Interest:

Bidders having a conflict of interest shall not be eligible to participate in the tender process unless the conf lict stemming from such relationship has been resolved in a manner acceptable to the Procuring Entity thr oughout the Tender process and execution of the Contract. The bidder shall be considered to have a conflict of interest in this tender process and execution of the resultant contract in the following situations:

- a) If its personnel have a close personal, financial, or business relationship with any personnel of the procuring entity who are directly or indirectly related to the procurement or execution process of the contract, which can affect the decision of the procuring entity directly or indirectly;
- b) The bidder (or his allied firm) provided services for the need assessment/ procurement plannin g of the Tender process in which it is participating;
- c) A Principal can authorize only one agent, and an agent should not represent or quote on behal f of more than one Principal. However, this shall not debar more than one Authorised distributo r (with/ or without the OEM) from quoting equipment manufactured by an Original Equipment Manufacturer (OEM) in procurements under a Proprietary Article Certificate or;
- d) A bidder participates in more than one bid in this tender process. Participation in any capacity by a Bidder (including the participation of a Bidder as a partner/ JV member or sub-contractor in another bid or vice-versa) in more than one bid shall result in the disqualification of all bids in which he is a party. However, this does not limit the participation of an entity as a sub-contractor in more than one bid if he is not bidding independently in his own name or as a member of a JV.

xii. Delay in supplier's performance:

Time is essence of the contract and completion of delivery dates agreed to are binding on the supplier . In the event the supplier is not able to supply as per the delivery schedules given by BNPM, Purchase r will have a right either to cancel the order without prejudice to any other rights or to make purchase from an alternate source at the risk and cost of the seller.

In case of rejection and failure to replace goods, the order will be treated as incomplete and BNPM may cancel the order and will arrange to purchase the goods from elsewhere at supplier's risk and cost and the purchase order on supplier shall be cancelled and action taken as per the order terms.

xiii. Vendor Performance:

Vendor shall be evaluated for their performance. The performance shall be based on timeliness of deliveries, quality of the material supplied, technical support, quality of after-sales service if any, replace ment of the defective material if any, responsiveness etc. Based on the above criteria, the vendor shall be rated in category "A", "B" & "C". The vendor with rating "C" shall be disqualified/debarred from

participating in the tender for period of 12 months.

xiv. Extension of Time:

If the contract is delayed in the progress of work by changes ordered in the work, or any clause which BNPM shall decide to justify the delay, then the time of completion shall be extended by a reasonable time.

If at any time during the currency of contract, the supplier encounters conditions hindering timely delivery of the goods and performance of services, the supplier shall promptly inform BNPM in writing about the same and its likely duration and make a request to BNPM for extension of the delivery schedule accordingly. On receiving the supplier's communication, BNPM shall examine the situation as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liquidated d amages for completion of supplier's contractual obligations by issuing an amendment to the contract.

xv. Risk Purchase Clause:

If the supplier fails to abide by the terms and conditions of this agreement, or fails to supply the mater ial as per the delivery schedule or any time repudiates the contract, the purchaser will have the right to

- a. Appropriate the Security Deposit (by invoking the Bank guarantee/performance security) deposited by the supplier and procure the tender item from other agencies at the risk and cost of the supplie r.
- b. The cost difference between the alternative arrangement and supplier's tendered value will be recovered from the supplier along with the other incidental charges.

In case of procurement through alternative sources, and if procurement price is lower, no benefit on this account will be passed on to the supplier.

xvi. Fore-Closure Clause:

If at any time during the continuation of this contract, the use of material ordered in this contract is co mpletely banned or due to drastic change in Government policy its use as, raw material is discontinue d or is declared hazardous to public health or cause rising to civil commotion, epidemics, wide-spread strikes and 21 days' notice of such eventualities is given by purchaser to the supplier, the supplier wit hout any right to enforce the contract, will agree to the fore-close the performance of balance portion of this contract and in that event no claim for damages or loss will be lodged against the purchaser.

xvii. Force Majeure:

In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by BNPM in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.

xviii. Settlement of Disputes through Arbitration:

All disputes and differences of any kind whatsoever arising out of or in connection with the contract, w hether during the progress of the work or after their completion except accepted matters shall be sett led through arbitration process as per the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysore, Karnataka.

xix. Legal Jurisdiction:

The Courts of Mysore (Karnataka State) shall alone have jurisdiction to decide on any legal matter of dispute whatsoever arising out or in respect of the contract.

xx. Security and Confidentiality:

BNPMIPL is a security organization and the premise is declared as 'Prohibited Area' by the Govt. of Kar nataka. Hence the service provider has to abide by the security rules of the Company.
