If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

Part Quantity Bidding

Buyer has allowed part quantity bidding, bidders can offer maximum quantity that they can deliver keeping in mind their capacity and delivery period requirements. The offer quantity has to be more than minimum bid quantity as specified by the Buyer in the bid. Offers with quantity less than Minimum are liable to be rejected. It may however be noted that there is no guarantee that full offer quantity will be ordered by the buyer. Quantity to be ordered by the buyer will depend on various factors including the Ranking of the bidder, Offered quantity, Splitting criteria indicated by the buyer in the bid and the requirement of the buyer to have multiple sources of supply for ensuring supply chain etc. Sellers would be notified about likely order quantity or range of possible order quantity at the time of price match request made by the buyer, ward of contract will be subject to acceptance of price match request along with min / max offer quantity as decided by the Buyer.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. ii. Terms of Payment:

100% within 30 days from the date of receipt and acceptance of goods at BNPM Plant, Mysuru and on production of all required documents by the supplier.

iii. Period Of Contract:

The Contract for a period of one (01) year from the date of issuance of PO.

iv. Delivery Schedule:

Delivery shall be made in staggered manner for a period of 01 year from the date of issue of PO as per delivery schedule promulgated by BNPM by emails.

v. Variation in Qty.: ±1%

vi. Packing:

It is desired that the caustic soda lye to be supplied in the tanker only.

vii. Packing Standards:

Each tanker shall carry a material dispatch sheet which showing the Name and grade of the material, Name of the manufacturer and his recognized trade-mark, if any, Mass of the material in kg; Month an d year of packing Batch number, Shelf Life etc.

viii. Performance Security:

Within twenty one (21) days after the issue of PO by BNPM, the supplier shall furnish performance sec urity to BNPM for an amount equal to 10 percent (10%) of the total value of the contract, valid till 18 months period and claim period of 2 months thereafter.

ix. Liquidated Damages (LD):

If the supplier fails to deliver any or all of the goods within the time frame(s) incorporated in the contr act, BNPM shall without prejudice to other rights and remedies available to BNPM under the contract deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% (Half) percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to maximum deduction of the 10% of the delayed goods' contract price(s).

x. Shelf Life:-

- i.) Shelf life Period for Caustic Soda Lye shall be minimum 12 months from the date of supply to BNPM, Mysore.
- ii.) In case of any claim arising out within the shelf life time, BNPM shall promptly notify the sam e in writing to the supplier.

- iii.) Upon receipt of such notice, the supplier shall, within a reasonable span of time (or within the period), replace the defective chemicals or parts thereof, free of cost, at the ultimate destinati on. The supplier shall take over the replaced chemicals after providing their replacements and no claim, whatsoever shall lie on BNPM for such replaced chemicals thereafter.
- iv.) In the event of replacement of chemicals during the shelf life period, the shelf life for the replaced chemicals shall be extended to a further period of minimum six months from the date su ch replaced chemicals starts functioning to the satisfaction of BNPM.
- v.) If the supplier, having been notified, fails to replace the chemicals within a reasonable period (i.e.15 days), BNPM may proceed to take such remedial action(s) as deemed fit by BNP M, at the risk and expense of the supplier and without prejudice to other contractual rights an d remedies, which BNPM may have against the supplier.

xi. Rejection Replacement:

Sample will be taken randomly, for lab testing. In case of supplies, materials not meeting our specifica tion will be rejected outright and the rejected material shall be taken back within 7 days at the cost a nd risk of the supplier and replacement should be made within 15 days from the date of intimation. N o payment shall be made for rejected item. If the material is not taken back within the stipulate period , BNPM reserves the right to dispose off the material at the risk and expense of the vendor.

xii. Delay in supplier's performance:

Time is essence of the contract and completion of delivery dates agreed to are binding on the supplier . In the event the supplier is not able to supply as per the delivery schedules given by BNPM, Purchase r will have a right either to cancel the order without prejudice to any other rights or to make purchase from an alternate source at the risk and cost of the seller.

In case of rejection and failure to replace goods, the order will be treated as incomplete and BNPM may cancel the order and will arrange to purchase the goods from elsewhere at supplier's risk and cost and the purchase order on supplier shall be cancelled and action taken as per the order terms.

xiii. Vendor Performance:

Vendor shall be evaluated for their performance. The performance shall be based on timeliness of deliveries, quality of the material supplied, technical support, quality of after-sales service if any, replace ment of the defective material if any, responsiveness etc. Based on the above criteria, the vendor shall be rated in category "A", "B" & "C". The vendor with rating "C" shall be disqualified/debarred from participating in the tender for period of 12 months.

xiv. Extension of Time:

If the contract is delayed in the progress of work by changes ordered in the work, or any clause which BNPM shall decide to justify the delay, then the time of completion shall be extended by a reasonable time.

If at any time during the currency of contract, the supplier encounters conditions hindering timely delivery of the goods and performance of services, the supplier shall promptly inform BNPM in writing about the same and its likely duration and make a request to BNPM for extension of the delivery schedule accordingly. On receiving the supplier's communication, BNPM shall examine the situation as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liquidated damages for completion of supplier's contractual obligations by issuing an amendment to the contract.

xv. Risk Purchase Clause:

If the supplier fails to abide by the terms and conditions of this agreement, or fails to supply the mater ial as per the delivery schedule or any time repudiates the contract, the purchaser will have the right to

- a. Appropriate the Security Deposit (by invoking the Bank guarantee/performance security) deposited by the supplier and procure the tender item from other agencies at the risk and cost of the supplie r.
- **b.** The cost difference between the alternative arrangement and supplier's tendered value will be re covered from the supplier along with the other incidental charges.

In case of procurement through alternative sources, and if procurement price is lower, no benefit on this account will be passed on to the supplier.

xvi. Fore-Closure Clause:

If at any time during the continuation of this contract, the use of material ordered in this contract is co mpletely banned or due to drastic change in Government policy its use as, raw material is discontinue d or is declared hazardous to public health or cause rising to civil commotion, epidemics, wide-spread strikes and 21 days' notice of such eventualities is given by purchaser to the supplier, the supplier wit hout any right to enforce the contract, will agree to the fore-close the performance of balance portion of this contract and in that event no claim for damages or loss will be lodged against the purchaser.

xvii. Force Majeure:

In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by BNPM in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.

xviii. Settlement of Disputes through Arbitration:

All disputes and differences of any kind whatsoever arising out of or in connection with the contract, w hether during the progress of the work or after their completion except accepted matters shall be sett led through arbitration process as per the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysore, Karnataka.

xix. Legal Jurisdiction:

The Courts of Mysore (Karnataka State) shall alone have jurisdiction to decide on any legal matter of dispute whatsoever arising out or in respect of the contract.

xx. Security and Confidentiality:

BNPMIPL is a security organization and the premise is declared as 'Prohibited Area' by the Govt. of Kar nataka. Hence the service provider has to abide by the security rules of the Company.
