**A. Scope of work :**

1. To collect swab sample of the person authorized by BNPMIPL at the hospital (successful bidder/ bidders).
2. To carry out RT-PCR test of the collected sample.
3. Submit RT-PCR Test report by email to the designated person of BNPM within 24 Hours of receipt of sample.

**B. Terms & conditions :**

1. Contract Period: 6 months from the date of issuance of order.
2. Payment terms: Original monthly bills are to be submitted at BNPM, Mysore by the successful bidder, payment will be released within 15 days of receipt of the bill at BNPM, Mysore. Payment will be made in INR and vide electronic transfer.
3. Price: Price will remain fixed and firm upto the contract period and there shall no escalation of price.
4. Evaluation process
  - a) Price bid will be considered for evaluation if the bidder comply all the terms and conditions of the enquiry.
