**I. NOTICE INVITING TENDER**

Bank Note Paper Mill India Private Limited (BNPM) is a joint venture company between Bharatiya Reserve Bank Note Mudran Private Limited (A wholly owned subsidiary of Reserve Bank of India) and Security Printing and Minting Corporation of India Limited (100% owned by Government of India), incorporated for setting up & manufacturing of bank note papers at Mysore.

1. E - Bids are invited by BNPM from eligible & financially sound bidders for **Sale of Empty Bobbins at BNPM, Mysore – 570003 for reuse.**

**Online mode of bid submission ( e tender) :**

- e. Class III Digital Signature Certificate (DSC) is mandatory to participate in e-Tenders. Participating bidders/Contractors have to make sure that they have the valid DSC. If not, they can procure from any of the RAs approved by CCA.
- f. Bidders/Contractors should upload and attach all the Scanned copies of technical documents/certificates in e-tendering website [www.tenderwizard.com/BNP](http://www.tenderwizard.com/BNP) pertaining to their eligibility criteria mentioned in the NIT, failing which, the bid will not be considered.

2. **Eligibility Criteria:** The prospective bidders should submit the documents as mentioned below.

- a) Proof of registration i.e., valid GST and PAN.
  - b) The bidder should be manufacturer of Security Thread.
- Documents to be submitted: Atleast One No of Order / contract / agreement copy (unpriced) carried out during last 5 years ending on 28.02.2203 should be submitted to substantiate the above criteria.

- c) Bidder shall be Individual/ firm/ company/ corporate / LLP / HUF / limited company intending to bid should be bonafide, experienced, technically competent, resourceful and financially sound to carry out the assigned order.

Documents to be submitted: Company's registration / Certificate of incorporation/Partnership Deed/Any other registration certificate as applicable.

- d) Empty Bobbins shall be used as reusable purpose- Declaration in letter head is to be submitted accordingly.

All the documents should be duly signed by the authorized person of the bidder. Power of attorney in Rs. 200 Stamp Paper /Board Resolution/proprietor declaration/Partners confirmation should be submitted for the signing authority from the competent authority of the company.

3. Online bids are to be submitted through e tender portal ([www.tenderwizard.com/BNP](http://www.tenderwizard.com/BNP)) only.

Note:

Against receipt of the following notification through email from tenderwizard portal, bidder must resubmit the bid even if the bidder have already submitted the bid through tenderwizard portal.

***Notification: If you have already submitted the tender, then ensure that you resubmit the tender. Else, your bid may be liable to be auto disqualified by the system. And service provider holds no responsibility for the same. In case, you are yet to submit the tender, then please ensure that you submit it before the tender closing time.***

#### 4. Bid submission procedure:

##### Online bids:

Tenders are to be uploaded on e-tendering portal [www.tenderwizard.com/BNP](http://www.tenderwizard.com/BNP) only in Two part bid system.

i) Part-I - Prequalification Bid & Techno-commercial Bid: Registration Fee, Tender Processing Fee, EMD/Bid Security Declaration as per Annexure A is to be submitted ( For MSE Bidder) ,Scanned copy of supporting documents related to eligibility criteria (As mentioned in NIT) along with all sections , annexures of this tender (except Sec – IV, Price Schedule , which has to be submitted as mentioned in Sl.No.ii below) duly signed & stamped by authorised person in each & every page. (To be submitted through E-portal only)

ii) Part II – Price Bid: Price Bid shall be submitted through e-portal only, the price bid is liable for rejection if submitted in any other mode. Price Bid should be submitted as per

the price bid format provided in Sec -IV, Price Schedule of this tender. **Price Bid submitted in any other format will be liable for rejection. Price bids with conditions / Counter conditions are liable for rejection.**

5. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected. In line with evaluation criteria bid may be submitted item/schedule wise.

**6. Bid Validity:** The tender shall remain open for acceptance for a period of 120 days from the date of opening of the tender.

**7. EVALUATION CRITERIA:**

At first stage, techno-commercial bid will be opened and evaluated by the competent committee / authority with reference to the parameters prescribed in the tender document. Subsequently in the second stage the financial bids of only techno commercially acceptable offer as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.

The method of evaluation of price bid for awarding the sale order shall be on schedule/item wise Unit rate of H1 basis (effective rate basis i.e without GST).

- a. H1 will be awarded for the tentative generation of the quantity of reusable empty bobbins (As mentioned in Sec II) or the annual requirement of the bidder, whichever is lower.
- b. For the rest of the tendered quantity, the highest rate (H1 rate) will be counter offered to the H2 bidder. On acceptance of the counter offer, the order will be placed on H2 for the balance ( quantity after allocation to H1 bidder) tentative generation of the quantity of reusable empty bobbins (As mentioned in Sec II) or the annual requirement of the bidder of the bidder, whichever is lower and so on the other bidders.
- c. In case of non-acceptance of the counter offer by the H2 bidder, a similar offer shall be made to H3 bidder, and so on to the other bidders.
- d. After allocation of the quantity in the above mentioned process if any quantity is left out then same quantity may be offered to H1, at H1 rate and so on to other bidders if still any quantity is left out for allocation.
- e. If there is tie between the quoted rates of the bidders then preference will be given to the bidder having higher annual requirement of reusable empty bobbins as mentioned by the bidder in their techno commercial bid.
- f. However, the acceptance of the bid will rest with BNPM, who does not bind itself to accept the highest bid and reserves to himself the authority to reject any or all of the bids received without assigning any reason thereof.
- g. However, BNPM also reserves the right to allot the order partly or wholly to single or different Bidders. BNPM reserves the right to reject any offer including the highest one

if the same is not conforming to its norms. The decision of BNPM in this regard will be final.

NOTE TO BIDDERS: If it is observed that the discovered H1 rate against this tender is found to be more than the existing rate of the running contracts (if any), then rates of all the running contracts ( if any) are to be matched with the discovered H1 rate or order may be short closed.

**8. Discrepancy in Prices:**

- 8.1 If, in the price structure quoted by a bidder, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless BNPM feels that the tenderer has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.
- 8.2 If, there is an error in a total price, which has been worked out through addition and/ or subtraction of subtotals, the subtotals shall prevail and the total corrected; and
- 8.3 If, there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail.
- 8.4 If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the tenderer by registered/speed post/email. If the tenderer does not agree to the observation of BNPM, the tender is liable to be ignored.

- 9. EMD :** Interest free EMD of **Rs 1,89,000/- (Rupees One Lakh Eighty Nine Thousand only)**. The EMD shall be paid through Bank Guarantee (As per the format provided in the tender)/ online at e-tender portal [www.tenderwizard.com/BNP](http://www.tenderwizard.com/BNP) . The tender without EMD shall be liable for rejection.

Submission of EMD is exempted for Micro and small enterprises (MSEs) as per the Public Procurement Policy for MSEs Order, 2012. MSEs should be registered and also will continue to remain registered during the tender validity period with District Industries Centre (DIC) or Khadi and Village Industries Commission (KVIC) or Khadi and Industries Board (KVIB) or Coir Board or National Small Industries Commission (NSIC) or Directorate of Handicrafts and Handlooms or UDYAM or Any other body specified by Ministry of MSME. For EMD waiver, valid NSIC/UDYAM/any other doc as applicable is to be submitted along with Annexure A (Bid Security Declaration).

- 10. Refund of EMD:** EMD of Unsuccessful bidders will be returned to them without any interest, after expiry of the tender validity period, but not later than thirty days after conclusion of the resultant contract. EMD of successful Bidder will be released on submission of BG against Security Deposit. The value of Security Deposit will be 3% of the contract/order value. EMD shall be interest free.
- 11. Security Deposit (SD):** Within 10 days of receipt of order, SD of 3% of the total order value has to be submitted by the successful bidder, SD will be valid upto 60 days after

the contract period. If the successful bidder fails to resume/complete the work within stipulated time, SD of such bidder shall be forfeited. SD shall be interest free.

- 12. Terms of Sale:** Successful Bidder has to submit advance amount which is equivalent to the value of the empty bobbins to be lifted preferably 3 days before lifting the material. The advance payment should be made vide electronic transfer/Deposit to the Bank Account of Bank Note Paper Mill India Pvt Ltd.

Successful Bidder shall be allowed to lift the material only if the advance amount is equivalent to the scrap to be lifted.

- 13. Site Visit/ Inspection:** To assess the state/ conditions of empty bobbins and to determine the price to be quoted, the Bidder may visit the project site on or before tender submission due date and time and to get acquainted with the conditions at the site.

**14. General Terms & Conditions : Tenders for Sale of Empty Bobbins:**

The tender is for Sale of Empty Bobbins. Details of items for sale including Description, Lot Size would be given in the "List of Sale of Items ".

- a.** "As Is; Where Is" Basis of This Sale:
- b.** This sale of Empty Bobbins is strictly on "As Is; Where Is" basis. Tenderer must satisfy himself on all matters with regard to quality, quantity; nature of stores etc., before tendering as no complaint or representation of any kind shall be entertained after the sale contract is concluded.
- c.** The description of lot in the particulars of sale( if mentioned) has been given for the purpose of identification thereof only and the use of such description shall not constitute the sale thereof to be sale by description and no sale shall be invalid by reason of any defect or deviation or variation in any lot or on account of any lot not being exactly described and the purchaser shall not be entitled to claim any damage or compensation whatsoever on account of such fault, error in description, weight or the like.
- d.** All quantities of Empty Bobbins whether by weight or measurement mentioned in the Tender notice are only approximate and should the quantity, on actual weight or measurement basis as the case may be and whenever delivered on such basis, works out less than the advertised and /or projected quantity, the BNPM shall not under any circumstances be liable to make good any such deficiency
- e.** BNPM reserves the right to increase or decrease the quantity of any item or items or terminate the contract at any stage by giving one week's notice. No claim whatsoever shall lie against the BNPM on account of such termination of the contract or variation in the quantity.
- f.** BNPM shall have the right to remove certain items( as & if applicable) which it feels were not intended for sale but were inadvertently made a part of the scrap material or of the lot offered for sale lying at the premises or were joined or attached to the material offered for sale.
- g.** Tenderers desirous of purchasing and participating in the tender may visit the site before submitting the offer, after taking due permission from BNPM. The Tenderers submitting the offers shall be deemed to have visited the site and acquainted

themselves thoroughly with materials intended for sale in all respect.

- h. Any person giving offer shall be deemed to have made himself fully conversant with the Terms and Conditions of the Tender Sale, as well as the location and condition of the materials being sold and shall be deemed to have agreed to all the stated terms and conditions herein under.

**15. Disposal Tenders for Security and Sensitive Machinery and Items ( as & if applicable)**

**Non-Misuse Declaration:** The bidder is required to give an undertaking that he or his employees or legal heirs will ensure that such items purchased from BNPM, will be utilized only for scrap recovery and will not be misused for any other purpose. He will also ensure that this undertaking is honored and it got underwritten from further down the line scrap processors/ re-purchasers, if any. In case his firm changes hands, it will be his responsibility to ensure that the new owners honor and underwrite this undertaking.

**16. Procedure for Sale of Empty Bobbins:** On finalization of tender, a sale order will be issued to successful bidder by BNPM for the existing available quantity, which has to be lifted within 45 days from the date of issue of sale order. Thereafter as per the schedule provided by BNPM, empty bobbins may be lifted.

The successful bidder shall make advance payment as mentioned above for the material to be lifted. Bidder shall arrange vehicle, if any, Tools & tackles /materials required & labour for collection from various places in the site, loading, transportation at his own cost. The safety of the labour will be the responsibility of the bidder. The operation is to be completed within the specified office hours i.e. between 1000 hrs and 1600 hrs. No work shall be permitted on Sundays or on closed holidays.

Bidder shall not be allowed to pick and choose the materials. Empty bobbins are to be lifted as per the instruction of BNPM only. These material should not be sold to the employees of BNPM. Undertaking this regard has to be provided.

**17. Compliance of security Norms:**

BNPM is a security organization located in the premises of BRBNMPL and the Govt. of Karnataka declares the premises as Prohibited Area. Hence the contractor has to abide by the security rules of the Company. The contractor has to ensure the character and antecedent of the persons deployed. The contractor must be in a position to produce such documents whenever he is asked to do so. Details shall be furnished as per format when called for. The contractor has to issue printed photo identity card to its workers duly authenticated by the designated security officer of the Company. Contractor should apply for Gate Pass for labours, welding permission and material entry pass etc. as per approved format only, well in advance to avoid any delay in issue of Gate passes.

**18. Contract Period:** One year from the date of issuance of order. However BNPM reserves the right to short close the contract with 15 days' notice .

**19. Against receipt of the following notification through email from tenderwizard portal, bidder must resubmit the bid even if the bidder have already submitted the bid through tenderwizard portal.**
