Section I.
NOTICE INVITING TENDER

1. Bank Note Paper Mill India Private Limited (BNPM) is a joint venture company between Bharatiya Reserve Bank Note Mudran Private Limited (A wholly owned subsidiary of Reserve Bank of India) and Security Printing and Minting Corporation of India Limited (100% owned by Government of India), incorporated for setting up & manufacturing of bank note papers at Mysore.
2. Bids may submitted in online (e tender) or in offline (sealed bid) mode for Sale of Hazardous Waste (Scrap) at BNPM, Mysore – 570003 by eligible & financially sound bidders.

A. Online mode of bid submission (e tender) :

- a. Interested tenderers may obtain further information about this requirement from the above office selling the documents. They may also visit our website www.tenderwizard.com/BNP mentioned above for further details.
- b. Aspiring Bidders/Contractors who have not registered in e-tendering should register through the website E - Tendering (www.tenderwizard.com/BNP) for participating in the Online Tenders. **The registration charges will be Rs. 500/- plus applicable taxes (per year) which needs to be paid through electronic mode only. Tender processing fee is Rs. 1000/- plus applicable Taxes.**

- e. Class III Digital Signature Certificate (DSC) is mandatory to participate in e-Tenders. Participating bidders/Contractors have to make sure that they have the valid DSC. If not, they can procure from any of the RAs approved by CCA.
- f. Bidders/Contractors should upload and attach all the Scanned copies of technical documents/certificates in e-tendering website www.tenderwizard.com/BNP pertaining to their eligibility criteria mentioned in the NIT, failing which, the bid will not be considered.

B. Offline mode of bid submission (sealed bid):

3. **Eligibility Criteria:** The prospective bidders should submit the documents as mentioned below.
 - a) Proof of registration i.e., valid GST and PAN.



- b) Bidder shall have KSPCB/ CPCB /respective SPCB (in case of sale involving transboundary movement) authorization for handling the following :
- i. Bidder should have valid consent from KSPCB/CPCB/SPCB for disposal / recycling/ reprocessing Hazardous Waste Category 33.1 (Empty Barrels/Containers used for storage of haz. Chemicals), Category 5.1 (Used Oil), Category 5.2 (Waste/ Residue Containing Oil) as applicable for **Empty Barrels/ Containers/ Liners/ Drums, Spent or used oil, compressor oil filer (MS), cotton cloth waste contaminated with hazardous chemicals, Used Oil and Waste containing oil** as per Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016.
 - ii. Bidder should have valid consent from KSPCB/CPCB/SPCB for disposal / recycling/ reprocessing of **Hazardous waste Category 33.1** (Empty Barrels/ Containers/ Liners contaminated with hazardous chemicals or wastes).
 - iii. Bidder should have valid consent from KSPCB/CPCB/SPCB for disposal / recycling/ reprocessing of **Hazardous Waste Category 5.2** {Cotton Cloth Wastes or Residues containing oil , Transformer Oil Drums (MS), Lubricating Oil Drums(MS) , Compressor Filters (MS) }
 - iv. Bidder should have valid consent from KSPCB/CPCB/SPCB for disposal / recycling/ reprocessing of **Hazardous waste Category 5.1** (Spent oil/Used Oil: Transformer Oil, Lubricating Oil) shall be collected from BNPM premises as per the KSPCB/CPCB regulations.
 - v. To be submitted in Letter Head with sign & stamp :
 - i. Hazardous wastes shall be collected from BNPM premises as per the KSPCB/CPCB regulations.
 - ii. Loading, transportation, unloading, reprocessing shall be done by the bidder as per hazardous & other waste (Management & transboundary movement) Rule 2016. Any deviations during the process shall be solely attributed to the bidder. Bidder required to abide to the guidelines prescribed by the KSPCB/CPCB/SPCB.
 - iii. Bidder, without failing, shall obtain **Form 9 (Transport Emergency Card/TREM)** duly filled from the BNPM before the hazardous waste leaving the premises of BNPM.
 - iv. The transportation of the hazardous waste shall be in accordance with the existing rules and guidelines by the respective pollution control board and in accordance with the rules made by central Govt under motor vehicles act 1984. The transportation vehicle shall have along with it, the **Fitness certificate of the vehicle**, valid documents/authorization from KSPCB/CPCB/SPCB for the transportation of the Hazardous waste.
 - v. The responsibility of the safe transport of the hazardous waste shall be sole responsible of the receiver and shall have the necessary authorization for the transportation by the concerned state pollution control board. The same shall be clearly indicated in the manifest (Form -10).
 - vi. On receipt of the material, Form 10 - Hazardous Waste Manifest for disposal shall be sole responsible of the receiver and shall have the necessary

- authorization shall be issued to BNPMIPL. It will be the sole responsibility of bidder to use the material as per KSPCB/CPCB norms.
- vii. In case of transportation of hazardous and other waste for final disposal to a facility existing in a State other than the State where the waste is generated, the sender shall obtain '**No Objection Certificate**' from the **State Pollution Control Board of both the States**.
 - viii. Bidder shall maintain records of hazardous waste purchased in a passbook issued by the State Pollution Control Board along with the authorization.
 - ix. Hazardous waste shall be handed over to the **bidder only after making the entry into the passbook** Issued by KSPCB/CPCB.
4. Online bids are to be submitted through e tender portal (www.tenderwizard.com/BNP). 5. Bid submission procedure:

A. Online bids :

i) Part-I - Prequalification Bid & Techno-commercial Bid: Scanned copy of supporting documents related to eligibility criteria (As mentioned in NIT) along with all sections of this tender (except section – IV, Price Schedule , which has to be submitted as mentioned in Sl.No.ii below) duly signed & stamped by authorised person in each & every page. (To be submitted through E-portal only)

ii) Part II – Price Bid:

Price shall be furnished through e-portal only.

Price offer submitted in any other format will be liable for rejection.

B. Offline Bids :

Both the envelopes shall be put in one envelope and super subscribed **“Tender for Sale of Hazardous Waste”**.

6. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected.
7. Tenderers should quote their prices and rates both in figures and in words. No blank spaces shall be left. All erasures and corrections made while filling up the tender shall be initiated by the tenderer. Inline with evaluation criteria bid may be submitted item/schedule wise.
8. **Bid Validity:** The tender shall remain open for acceptance for a period of 120 days from the date of opening of the tender.
9. **EMD(Earnest Money Deposit)** : Not applicable for this tender, however bid security declaration as par Annexure A is to be submitted.
10. **EVALUATION CRITERIA:**
 - 10.1 At first stage, techno-commercial bid will be opened and evaluated by the competent committee / authority with reference to the parameters prescribed in the tender document. Subsequently in the second stage the financial bids of only techno commercially acceptable offer as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.
 - 10.2 **The method of evaluation of price bid for awarding the sale order shall be on schedule/item wise H1 basis against effective price (i.e without GST) only. If the schedule wise H1 prices are same for different bidders then the order will be placed on proportionate quantity basis.**
 - 10.3 However, the acceptance of the tender will rest with BNPM, who does not bind himself to accept the highest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason thereof.
 - 10.4 BNPM also reserves the right to allot the order partly or wholly to single or different Tenderer. BNPM reserves the right to reject any offer including the highest one if the same is not conforming to its norms. The decision of BNPM in this regard will be final.
11. **Discrepancy in Prices:**
 - 11.1 If, in the price structure quoted by a bidder, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price will be corrected accordingly, unless BNPM feels that the bidder has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.
 - 11.2 If, there is an error in a total price, which has been worked out through addition and/ or subtraction of subtotals, the subtotals shall prevail and the total corrected; and
 - 11.3 If, there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail.
 - 11.4 If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the bidder by registered/speed

post/email. If the bidder does not agree to the observation of BNPM, the tender is liable to be ignored.

12. **Security Deposit (SD):** Within 10 days of receipt of order, SD of 3% of the order value has to be submitted by the successful bidder, SD will be valid upto 60 days after the contract period. If the successful bidder fails to resume/complete the work within stipulated time, SD of such bidder shall be forfeited. SD shall be interest free. **If the successful bidder fails to submit the Security Deposit & does not lift the scrap material within 2 months of order placement, then BNPM has the right to cancel the order & debar/blacklist that bidder.**

13. **Terms of Sale:** Successful Bidder has to submit advance amount which is equivalent to the value of the scrap to be lifted preferably 3 days before lifting the material.

The advance payment should be made vide electronic transfer/ Deposit to the Bank Account of Bank Note Paper Mill India Pvt Ltd.

Successful Bidder shall be allowed to lift the material only if the advance amount is equivalent to the scrap to be lifted.

14. **Site Visit/ Inspection:** To assess the state/ conditions of scrap to determine the price to be quoted, the Bidder is advised to visit the project site before bid submission due date and time to get acquainted with the conditions at the site.

For visiting BNPM, Mysore plant prior permission is to be taken by prospective bidders from competent authority at BNPM, Mysore and to be visited with RT PCR negative report (not older than 72 hours) accordingly. Email may be send at scm.tender@bnpmindia.com in this regard.

15. **Completion Time:** Work for lifting the available scarp materials shall be started within 7 working days of issue of Sale Order and lifting of the available scrap should be finished within 45 days from the issue of Sale Order. The scrap materials available thereafter shall be lifted as and when available and as per the schedule provided by BNPM for disposal up to a period of One Year from the date of issuance of order with same ordered price and terms & conditions.

16. **Procedure for Disposal of Hazardous wastes:**

On finalization of tender, a sale order will be issued to successful bidder by BNPM for the existing available quantity, which has be to be completed lifting within 45 days from the date of issue of sale order.

The contractor shall make advance payment as mentioned above for the material to be lifted. Bidder shall arrange vehicle, if any, Tools & tackles /materials required & labour for collection from various places in the site, loading, transportation at his own cost. The safety of the labour will be the responsibility of the bidder. The operation is to be completed within the specified office hours i.e. between 1000 hrs and 1600 hrs. No work shall be permitted on Sundays or on closed holidays.

Bidder shall not be allowed to pick and choose the materials. Hazardous waste has to be lifted as per the instruction of BNPM only. These material should not be sold to the employees of BNPM. Undertaking this regard has to be provided.

17. **Tender Evaluation and award of work:** Tenders will be evaluated as per the terms and based on responsiveness taking into account all relevant factors. While the item/schedule wise H-1 will generally be the criteria, BNPM reserves the right to reject



- any offer including the H-1 if the same is not conforming to its norms. The decision of BNPM in this regard will be final.
18. **Termination of contract:** Successful bidder should adhere the schedule of lifting of the scrap as provided by BNPM time to time. During the execution of the contract if the performance of the bidder is found unsatisfactory BNPM has the right to (i) Terminate the contract (ii) Forfeit the security deposit amount (iii) Debar/ Blacklist the bidder.
19. **Compliance of security Norms:**
BNPM is a security organization located in the premises of BRBNMPL and the Govt. of Karnataka declares the premises as Prohibited Area. Hence the contractor has to abide by the security rules of the Company. The contractor has to ensure the character and antecedent of the persons deployed. The contractor must be in a position to produce such documents whenever he is asked to do so. Details shall be furnished as per format when called for. The contractor has to issue printed photo identity card to its workers duly authenticated by the designated security officer of the Company. Contractor should apply for Gate Pass for labours, welding permission and material entry pass etc. as per approved format only, well in advance to avoid any delay in issue of Gate passes
20. **Purchase preference for Micro & Small Enterprises:** Public procurement policy for Micro and Small Enterprises (MSEs) order, 2012 towards purchase preference is notified by Govt of India (GOI) along with its amendments is available in www.msme.gov.in. MSEs should have valid **UDYAM registration certificate / NSIC** to be considered under purchase preference for Micro & Small Enterprises (*MSE). **However this is a sale tender and not a purchase tender thereby preference is not applicable.**
