- c) General Criteria: Bidder to submit following declaration:

#### 7. EVALUATION CRITERIA:

Subsequently in the second stage the financial bids of only techno commercially acceptable offer as decided in first stage shall be opened for further scrutiny and evaluation. #### 8. **Discrepancy in Prices**:
