Price shall be furnished through e-portal only. Price offer submitted in any other format will be liable for rejection.

- **3. Work Schedule**: Successful contractor shall complete the work within 4 weeks form the date of intimation received from BNPM, Mysore. Work shall be done as and when required basis within the validity of WO.

all charges otherwise the quotation is likely to be rejected. Prices quoted for free delivery at destination (i.e., Mysore) will be given preference. If there is no indication regarding the FOR, in the quotation, then it will be considered as FOR destinations. Price quoted should be net and valid for a minimum period of three months from the date of opening of the quotation.

- i) The technical bids shall be opened in the first instance and these bids shall be scrutinised and evaluated by the competent committee/ authority with reference to the parameters prescribed in the tender document. Subsequently, in the second stage the financial bids of only technically acceptable offers as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.
- ii) The method of evaluation of bidder for awarding the Contract shall be on consolidated grand total offered by the bidder and will be decided taking into consideration of the total offered price for delivery up to BNPM, Mysore.
- iii) All responsive tenderers shall be evaluated as per the terms & conditions of the tender. The basis for arriving at the lowest responsive bidder shall be as per the price quoted for landed cost at Mysore including GST, packing & forwarding charges, freight, insurance and any other charges etc. and input credit shall be deducted to arrive at the effective price. Effective price shall be considered for arriving the lowest responsive bidder.
- iv) Bidder has to quote GST rate as per the HSN code provided in Section XI: Price Schedule. In case of any mismatch in HSN code with respect to offered product, same shall be decided in consultation with winning bidder.
- **19.** In case the items in the enquiry are covered by any rate contract or running contract finalized by the DGS&D or any other state or central Government, is should be specified in your quotation and accepted contract rates should also be mentioned. It should be confirmed whether you could supply at the RC rates outside rate contract.
- **20.** Payment of GST is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the quotations. If no indication regarding GST is recorded in the quotation, the GST will be considered as included.
- **21.** Delivery period required for supplying the material should be invariably specified in the quotation.
- **22. Liquidated Damage:** In case your quotation is accepted and order is placed on you, the supply against the order should be made within the period stipulated in the order. BNPMIPL reserves the right to recover any loss sustained due to delayed delivery by way of penalty. Failure to supply the material within the stipulated period shall entitle BNPM to impose liquidated damages without assigning any reasons @ 0.5% (Half Percent) of the total value of the item covered in order as LD per week or part thereof subject to a maximum of 10% (Ten Percent) which you unconditionally and expressly agree to unless extension is obtained in writing from the office on valid ground before expiry of delivery period.
- **23. Risk Purchase Clause**: If the deliveries are not maintained and due to that account BNPM is forced to buy the material at your risk and cost from elsewhere after due notice

to you, the loss or damage that may be sustained there by will be recovered from the defaulting supplier.

- **24. Payment terms:** 100% payment shall be released within 30 days after successful completion of the work and duly certified by BNPM officials after submission of bill.
- **25. Settlement of Disputes through Arbitration:** All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after their completion except accepted matters shall be settled through arbitration process as per the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysore, Karnataka
- **26. Legal Jurisdiction:** The Courts of Mysore (Karnataka State) shall alone have jurisdiction to decide on any legal matter of dispute whatsoever arising out or in respect of the contract.
- **27.Repeat Orders:** Bidders may note that, quantity of maximum upto 50% of the total ordered quantity against this enquiry may be considered for repeat order within a period of 06 months from the date of completion of last work made in the WO ordered against this enquiry with terms & conditions remaining same as per the original WO.
- **28.** Force Majeure: In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by BNPM in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.
- **29.** Fore-Closure Clause: If at any time during the continuation of this contract, the use of material ordered in this contract is completely banned or due to drastic change in Government policy its use as, raw material is discontinued or is declared hazardous to public health or cause rising to civil commotion, epidemics, wide-spread strikes and 21 days' notice of such eventualities is given by purchaser to the seller, the seller without any right to enforce the contract, will agree to the fore-close the performance of balance portion of this contract and in that event no claim for damages or loss will be lodged against the purchaser.
- **30. Rights of Rejection:** BNPMIPL reserves the right to reject any or all the applied bids without assigning any reason whatsoever. The enquiry can be rejected on national security grounds.
- **31. Preference for Micro and Small Enterprises (*MSEs):** Public procurement policy for Micro and Small Enterprises (MSEs) order, 2012 as notified by Govt of India (GOI) along with its

S. No	Item description	Scope of work
1	Repair & Re- Conditioning of Non Drive End Bearing Housing of Andritz Refiner	 Centre axis of rotor must be collinear and properly aligned with the centre axis of bearings. So reference of bearing housing centre to be taken from radial shaft seal seating area. As housing is not having uniform shape, hence CNC Milling machine is required for machining. Bearing housing face should be perfectly levelled before starting the machine. Once the levelling of housing is done, reference of bearing housing centre has to be taken from radial shaft seal seating area. Centre axis of rotor must be collinear and properly aligned with the centre axis of bearings so centring of bearing seating has to be done precisely. After fixing the centre, damaged part of bearing seating area has to be machined up to diameter of 190 mm to 192 mm (by giving an undercut of 5 mm - 6 mm) A bush of grey cast iron grade : FG 400 (with internal diameter of 179 mm and outer diameter with shrink fit tolerance to the diameter of bearing seating (i.e. 190 mm to 192 mm) has to be made ready. Tolerance for 0.D may be decided based on availability of liquid nitrogen or dry ice. Width of the bush should be equal to the width of bearing seating area (i.e. 60 mm). Now bush has to be shrink fitted in the bearing seating area and need to be locked by providing grub screws at 03 places @ 120 ° apart. Now internal surface of bush need to be machined to final diameter of 180 mm with H7 tolerance (i.e. 180 +0.03 mm). During machining of damaged bearing seating area centre of bearing should not get disturb, hence to maintain collinearity of centre all the machining activities must be done on CNC milling machine only. If contractors works is within 10 Km form BNPM, Mysore, to & fro transportation charges is under BNPM scope and if the distance is more than 10 Km to & fro transportation is under contractor scope.

 - d) An entity whose beneficial owner is situated in such a country; or
 - e) An India (or other) agent of such an entity; or
 - f) A natural person who is a citizen of such a country; or
 - g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.
- III) The beneficial owner for the purpose of (iii) above will be as under :-

IV) An agent is a person employed to do any act for any another, or to represent another in dealings with tired person.

V) The successful bidder shall not be allowed to sub contract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Authority.
