1. Delivery Schedule

Collection of samples is to be done after getting instruction of BNPMIPL and in the presence of BNPMIPL / KSPCB representatives.

The suppliers are required to adhere the following procedure in order to honour the payment against CGST, SGST, IGST & UTGST in the invoice:

- An invoice issued by the supplier of goods or services or both should be in accordance with the provisions of section 31 of the CGST Act and should contain all the prescribed informations in accordance with Chapter VI of CGST Rules, 2017;
- ii. A debit note issued if any, by a supplier should be in accordance with the provisions of section 34 of the CGST Act;
- iii. The supplier should mandatorily upload the aforementioned documents in GSTR -1, details of outward supplies of goods or services within the prescribed time under GST Act;
- iv. The supplier should provide the relevant documents to confirm the tax charged on the invoice has been paid to the credit of government after adjusting with ITC if any.

Notwithstanding above, the supplier should provide indemnification as follows:

"In the event of non-compliances with respect to GST Act and Rules by the supplier, the purchaser is allowed to adjust the GST amount from retention amount (either in BG or in Cash) held by the company. If no amount is available for recovery, the supplier will refund the GST liability within 10 days from the date of GST reversal in GSTRN"

The above requirements are mandatory to claim any GST liability, failing which, the GST liability will not be paid/reimbursed/accepted.

4.0 Liquidated Damage

4.1 Subject to GCC clause 28, if the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, BNPM shall, without prejudice to other rights and remedies available to BNPM under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% (Half) percent (or any other percentage if prescribed in the SCC) of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% (or any other percentage if prescribed in the SCC) of the delayed goods' or services' contract price(s). - 4.3 If the equipment/system while testing, in accordance with the performance requirement of the Contract, fails to meet those performance parameters, the damages suffered by the purchaser may not quantified in terms of money with any reasonable certainty. Therefore any Liquidated damage set forth in the Contract shall represent a reasonable determination of the amount of damage that the Purchaser will suffer, and shall not be considered as penalties. - 4.4 The maximum amount of liquidated damage on any account shall not exceed 10% of the contract price.

1. Analysis of Ambient Air Quality, Stacks emission & ETP Gardening water.

Quality of ambient air shall be checked at 03 locations in plant as identified by BNPM/KSPCB

Stack monitoring / smoke samples shall be collected from

- Cotton pre-cleaning system,
- Boiler Chimneys (02 nos 56 mtrs & 46 mtrs height),
- Diesel Generator chimney (30 mtrs height),
- Firefighting Diesel pump chimney

ETP Gardening water Sample shall be collected from Effluent Treatment Plant

Sample should be analyzed for all mentioned parameters and any other additional parameters required by KSPCB / CPCB / MoEF. Testing and analyzing of Ambient Air quality, stack emission & treated effluent should be done in a laboratory/laboratories approved under EP act or NABL accredited labs or labs approved by KSPCB / CPCB

Vendor shall carryout the analysis of emission & effluent every month for the parameters indicated in CFO (Consent for Operation) granted to BNPM and Ambient air quality monitoring as per CPCB norms. Any future changes in parameters by KSPCB/CPCB shall also be carried out by vendor without any cost implication.
