  - B. Original + 1 photocopy of the Govt. approved photo ID proof (PAN / Voter ID / Aadhar Card / Driving License / Passport / etc.)
2. The candidates are requested to be present at the venue as per the Reporting Time mentioned above. Entry will not be allowed post the reporting time.
3. The company reserves the right to summarily terminate the participation of any candidate found to be indulging in any malpractice or misbehavior during the course of the event.
4. The above-mentioned candidates are called for the Offline Test without verifying their personal details viz. age, qualification, experience, etc. with original documents.
