Above referred work order was issued to M/s. Industrial Needs & Services, Mysore for providing, supplying and installation of toughened glass writing board at BNPM, Mysore. As per the work order the entire work shall be completed on or before 03.07.2024.

The supply of the material and completion of the ordered work was not completed within the work order completion period. Further there was no request for any extension we have received, and also you have not replied to the repeated mail communications referred above.

In view of the above, the following actions have been enacted on M/s. Industrial Needs and Serives, Mysore:-


- a. Termination/Cancellation of Work Order no BNPM/WO/2042/2024-25 dated 03.06.2024.
