Dear Sir,

This has reference to above mentioned Empanelment Letter for supply of cotton comber.

As per empanelment letter, you have failed to submit the required performance security amount of ₹50 lakh.

Purchase order no. BNPM/PO/1083/2022-23 dated 08.03.2023 was issued for supply of 2,00,000.00 Kgs Cotton comber. Subsequently, vide email dated 08.03.2023 delivery schedule was issued to supply entire quantity by 24.03.2023.

You have supplied only 25,469.50 Kg of Cotton Comber against the ordered quantity of 2,00,000.00 Kgs and 174,530.50 Kg is still pending. Therefore, a show cause notice no. 890/(C)02.12.12/2023-24 dated 17.07.2023 was issued due to non-delivery of Cotton Comber. The following actions were outlined in the notice:

- i. Forfeiture of performance security
- ii. Termination of contract/ Purchase Order/Delivery Schedule for default in suppose within the delivery dates.
- iii. Delisting M/s Creative Yarns from the empaneled vendor list.
- iv. Debarring M/s Creative Yarns, Coimbatore, from participating in the BNPM tender for one year.

On multiple occasion, you were given opportunity to submit performance security and then supply the pending quantity. However, vide email dated March 18, 2025, you have expressed your inability to fulfil the order due to significant losses and requested the release of the retained security deposit.

We bring in your notice that, you have been defaulted by failing to submit the required performance security amount of ₹50 lakh, and by not supplying the ordered quantity within the contract period. As you have failed to comply the contractual obligations.

Therefore, following actions are being imposed on M/s Creative Yarns, Coimbatore with effect from 11.06.2025:

- i. M/s Creative Yarns, Coimbatore, delisted from the Empaneled Vendor List
- ii. Purchase Order No. BNPM/PO/1083/2022-23 dated March 08, 2023, value ₹3,50,70,000/- issued to M/s Creative Yarns, Coimbatore stand cancelled.
- iii. M/s Creative Yarns, Coimbatore, debarred for participating in BNPM tenders for a period of two years from the date of the letter (i.e. till 10.06.2027).
- iv. Your retained Security Deposit amount of ₹43,76,756/- has been Forfeited.
