Dear Sir,

We draw to your kind attention to above referred show cause notice issued to you towards delay in supply of materials. As per provisions of tender clause **"Vendor Performance" under SCC, Section-V** may be noted:

"Successful bidder shall be evaluated for their performance. The performance shall be based on timeliness of deliveries, quality of the material supplied, technical support, quality of after-sales service if any, replacement of the defective material if any, responsiveness etc. Based on the above criteria, the vendor shall be rated in category "A", "B" & "C". The vendor with rating "C" shall be disqualified/debarred from participating in the tender for certain period."

Therefore, considering the past performance in terms of quality & delivery aspects, following administrative actions have been enacted on M/s. Pandit Agencies, Mysore.

- M/s. Pandit Agencies, Mysore shall be categorized as "B" category vendor and will not be allowed to participate in any RFQ/ tenders (including rate contracts) of BNPM beyond Rs.25,000/- (Incl. GST) of total cost for 12 Months w.e.f 04.11.2025.
- Henceforth, your participation against any RFQ/tenders will be by invitation only as receipt from BNPM. Unsolicited offers submitted will be liable to be ignored/ rejected.
- The performance of the M/s. Pandit Agencies, Mysore will be further reviewed by BNPM after one year for provision of recategorization if any.
